It is our mission to maintain a safe and healthy environment on behalf of our patients and staff. We have proactively taken the following measures in order to protect our patients and staff and to help prevent the spread of diseases like COVID-19 (coronavirus):

As of now, we are screening all other visitors and vendors who have business within our facility. This screening includes:

- Whether you have traveled to one of the 5 countries effected by COVID-19 within the last 14 days.
- If you have been in contact with someone diagnosed or being evaluated for COVID-19.
- If you have flu-like symptoms within the last 24 hours.

PATIENT ACTIVITIES OUTSIDE OF THE HOSPITAL

- 1) Until further notice, all brief visits except for brief visits for discharge planning purposes, are not allowed. This includes day passes with patient's family and friends.
- 2) Brief visits for discharge planning purposes will proceed at the discretion of the CEO, the Medical/ Clinical Director, and the Chief of Medicine. The decision to proceed will be made based on the clinical necessity of the visit, the patient's physical condition, and the current state of the COVID-19 outbreak in the location of the proposed brief visit.
- 3) Staff (or provider) accompanied community visits for discharge planning purposes will proceed at the discretion of the CEO, the Medical/ Clinical Director, and the Chief of Medicine. This decision will be made based on the clinical necessity of the visit, the patient's physical condition, and the current state of the COVID-19 outbreak in the location of the proposed brief visit.
- 4) Staff accompanied community visits with patients for community reintegration (shopping, dining etc.) or recreational purposes are cancelled until further notice.
- 5) Staff accompanied medical visits for urgent and emergent medical purposes are allowed. Questions about whether a medical visit is urgent should be resolved by the Chief of Medicine in consultation with the Medical/ Clinical Director, if necessary. Community visits for electroconvulsive therapy, dialysis, and other ongoing and necessary procedures are permitted. All elective medical visits should be postponed.
