### **GENERAL ADMINISTRATIVE REPORTS:**

- **Ancorage Commissary Statement** The ending cash balance for the Ancorage Commissary and Snack Cart as of January 31, 2024, is \$22,217.08. The total income for the month was \$10,997.10 and \$8220.97 were the total expenses for the month. The Ancorage building is closed currently for repairs to the flooring, but it is currently operating a mini canteen out of food service, we are hoping to open the Ancorage in the next six weeks.
- **Welfare Fund** The ending Welfare fund balance as of January 31, 2024, is \$1,907.41. There was a donation from a previous patients trust, 1% interest in the final distribution to be directed to the Hospital's Welfare Fund for the benefit of its patients.
- **Discharge Updates** Our current census is 297 patients, 21 patients on CEPP less than 6 months, 38 patients on CEPP longer than 6 months. The month of February there was 10 discharges and 11 admissions.
