GENERAL DESCRIPTION

Under direction of a supervisory official in a State department, institution or agency employing between 1,400 and 4,000 employees, supervises staff involved in the preparation of unit payrolls, and the preparation and maintenance of payroll and personnel records and other forms.

Will ensure accuracy of payroll records/payments using the e-CAT's (Electronic timekeeping system), conducts audits, prepares special payouts such as clothing allowance, lump sums, back pays and SOIL's. Participates in unemployment hearings, processes verification requests, and completes e-PAR staff evaluations. Prepares reports and analysis as requested.

Preference will be given to those candidates with experience submitting an e-cats payroll for a state agency.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EXPERIENCE:

Four (4) years of experience in the preparation and maintenance of personnel and payroll records, two (2) years of which shall have involved supervisory responsibility.

LICENSE:

Appointees will be required to possess a driver's license valid in NJ only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

PHEL Candidates:

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

Direct Client Care:

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey
First Act:**

In accordance with N.J.S.A. 52:14-7, the "New Jersey First Act", all employees must reside in the State of New Jersey, unless exempted under the law. If you do not live in New Jersey, you have one year after you begin employment to relocate your residence to New Jersey.

Resume Note:

Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

Authorization to Work:

Selected candidates must be authorized to work in the United States according to the Department of Homeland Security, United States Citizenship and Immigration Services Regulations. The State of New Jersey does **not** provide sponsorships for citizenships to the United States.

Note: Newly hired employees must agree to a thorough background check that will include fingerprinting.
