Under direction of a Crew Supervisor, a Building Maintenance Worker or other supervisor in a state department, institution, or agency, may be assigned to work as a helper; cleans and maintains offices, furniture, various buildings, grounds and patient areas. May make minor repairs; does other related duties as required. May perform housekeeping duties on patient wards.

Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
