GENERAL DESCRIPTION			
<p>This position will report to a higher level Clinical Laboratory Evaluator within the Clinical Laboratory Improvement Services (CLIS): Tissue Bank Licensing and Regulatory Compliance Program. The CLE1 will survey, review, evaluate, and document the performance of licensed Human Milk and Embryo Storage Banks and Distribution facilities. Candidate shall have some working knowledge in one or more of the following: Quality Assurance, Donor Suitability, Milk/Embryo Collection, Component Processing, Testing, Review and Labeling, Storage and Distribution, Compatibility Testing, Investigation of Adverse Effects and/or Information Management. The CLE 1 does other job related duties as required.</p>

<p>EDUCATION:</p> <p>Graduation from an accredited college or university with a Bachelor's degree in Medical Technology or a biological or chemical science which shall have included at least sixteen (16) semester hour credits in chemistry, sixteen (16) semester hour credits in the biological sciences, and three (3) semester hour credits in mathematics.</p> <p>NOTE: Possession of the qualifications of a Medical Technologist as required under Federal Medicare Regulations Subpart M Part 405:1315, Chapter 3, Title 20 of the Code of Federal Regulations for coverage of services of independent laboratories or under NJAC 8:44-2.6 may be substituted for the above education.</p> <p>EXPERIENCE:</p> <p>Two (2) years of experience as a medical technologist in specialties including but not limited to chemistry, microbiology, hematology, immunology, and cytology in a private/public/hospital clinical laboratory which shall have included training responsibilities.</p> <p>NOTE: A Master's degree in Medical Technology or related field may be substituted for one (1) year of indicated experience.</p> <p>LICENSE:</p> <p>Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.</p> <p>American Society of Clinical Pathology (ASCP) certification as a medical technologist may be required for federally funded positions.</p>

PHEL Candidates:

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

Direct Client Care:

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey
First Act:**

Resume Note:
