Under the direction of a supervisor, the Software Development Specialist 1 will collaborate with Cloud team and create, enhance and maintain System Development Life Cycle (SDLC) artifacts for various Health Information Technology Data Lake projects. Artifacts should include business requirements documents (BRDs), use cases, process diagrams, functional specifications, documentation of business rules, requirements traceability, defect logs, test cases, and release notes.

The candidate will test and verify the function and performance of changes to the existing software. Prepare flowcharts, review written requirements, and create block and swim lane diagrams. Adhere to documentation standards by creating and using templates.

The focus of this role is to document end-to-end solutions for automation and cloud enablement. The candidate will meet with Stakeholders to analyze and document existing business processes and technical issues and recommend business improvements. Identify, document and share repeatable process improvement opportunities for Department of Health (DOH), Health Information Technology (HIT) Cloud initiatives and in support of the statewide roll-out of enterprise applications.

The ideal candidate should have familiarity and understanding of principals supporting infrastructure components including compute, network, and storage within Cloud Architecture. This is a unique opportunity to be able to contribute and grow foundational cloud and DevOps skills across a diverse technology stack and architectures.

Responsibilities will also include analysis to ensure the proper data is available to support business needs. Conduct data profiling to identify data quality issues and work with Business and IT teams to resolve the issues. Create test cases and perform quality validation of data lake content to ensure accuracy.

The candidate should be a self-motivated team player and must possess excellent written and oral communication skills, with the ability to engage with all levels of stakeholders.

This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.

OR Possession of a master's degree in an information technology field.

NOTE: "Professional experience" refers to work that is analytical, evaluative, and interpretive; requires a range of basic knowledge of the profession's concepts and practices; and is performed with the authority to act and make accurate and informed decisions.

LICENSE:

Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.
