REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

EDUCATION: Graduation from an accredited college with a Master's degree in Social Work and license is required.

EXPERIENCE: One (1) year of experience in social case work, involving responsibility for gathering and analyzing social information from clients, the determination of their needs, and the planning and administration of treatment plans geared toward the needs of individual clients. NOTE: A Master's degree in Social Work including or supplemented by a supervised field placement accredited by the Council on Social Work Education may be substituted for the above stated experience requirements.

LICENSE: Registration as a Licensed Social Worker (LSW) in the State of New Jersey. Applicants may be in the process as long as there is evidence of a passing score on licensure exam and that the application has been submitted.

Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.

New Jersey
