Three (3) years of the required experience shall be in a first in-line supervisory capacity involving the care and treatment of psychiatric, geriatric, or developmentally disabled patients.</p> <p><b>NOTE:</b> Applicants who do not possess the Bachelors degree in Nursing must possess one (1) additional year of non supervisory experience.</p> <p><b>LICENSES. CERTIFICATIONS OR REGISTRATIONS:</b> Appointee will be required to possess a current professional license as a Registered Nurse valid in the State of New Jersey.</p> <p><b>SUBSTITUTION:</b> A Master's degree in Mental Health/Psychiatric Nursing, Nursing Education, Nursing Administration, or Health Services Administration may be substituted for one (1) year of the required non-supervisory experience.</p> <p><b>LICENSE:</b> Appointees will be required to possess a driver's license valid in New Jersey only if operation of a vehicle, rather than employeemobility, is necessary to perform essential duties of the position.</p>

**PHEL Candidates:**

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

**Direct Client Care:**

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey  
First Act:**

**Resume Note:**
