<p>Under the direction of a Supervisor of Inspections in the Long-Term Care Complaints (LTCC) program, this position is responsible for the review and processing of Facility Reportable Events as well as consumer complaints. Has oversight of intake tasks being completed by other intake staff, as assigned. Schedules intakes for onsite investigations by staff. Maintains complaint logs and spreadsheets for tracking status of complaint intakes pending assignment for survey. Utilizes the ASPEN and ACTS Federal database systems to access survey and certification information. Reviews and edits completed contractor surveys and conferences with contractor survey agencies as needed. Communicates with LTC healthcare facilities to provide information and regulatory guidance related to state and federal requirements. Provides appropriate regulatory guidance or other information and referrals to complainants. Assists with coverage for afterhours hotline calls.</p> <p>Preferred Experience: Survey experience in healthcare facilities and prior successful completion of the Surveyor Minimum Qualifications Test (SMQT).</p> <p>This position may be eligible to participate in the Department's pilot telework program, which offers eligible employees the opportunity to work remotely for up to two (2) days per week, as approved by management.</p>

If you are applying under the NJ "SAME" program, your supporting documents (Schedule A or B letter), must be submitted along with your resume by the closing date indicated above. PHEL Candidates:

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

Direct Client Care:

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey
First Act:**

In accordance with N.J.S.A. 52:14-7, the "New Jersey First Act", all employees must reside in the State of New Jersey, unless exempted under the law. If you do not live in New Jersey, you have one year after you begin employment to relocate your residence to New Jersey.

Resume Note:

Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

Authorization to Work:

Selected candidates must be authorized to work in the United States according to the Department of Homeland Security, United States Citizenship and Immigration Services Regulations. The State of New Jersey does **not** provide sponsorships for citizenships to the United States.
