### GENERAL DESCRIPTION

**\*\*IF PREVIOUSLY APPLIED TO THIS POSTING, 559-24, NO NEED TO REAPPLY\*\***

Under general direction of the Personnel Assistant 1, Payroll and Administrative, unit reviews and processes all Workmen's compensation claims and ADA requests within the department's central office. Provides guidance to employees and management regarding Workmen's compensation. Engages in the interactive process with employees and management for accommodation requests submitted under the Americans with Disabilities Act. Interacts with internal and external agencies to make accommodation recommendations and referrals. Prepares related correspondence for Manager's review and signature. Enters Workmen's compensation leaves and ADA's in the department's Leaves-Medi Track database. This position will also, audit, review, and make recommendations for all payroll and administrative matters including payroll, leaves, workmen's compensation cases and accommodation requests for the four psychiatric hospitals. Note – This position will require periodic travel to the four psychiatric hospitals.

### REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

**NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.**

**Seven (7) years of professional experience in the personnel program of a public or private organization.**

**OR**

**Possession of a bachelor's degree from an accredited college or university; and three (3) years of the above-mentioned professional experience.**

**OR**

**Possession of a master's degree in business administration, personnel administration, public administration, management, or other related field from an accredited college or university; and two (2) years of the above-mentioned professional experience.**

**NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgment and make accurate and informed decisions.**

**LICENSE: Appointee will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.**

**PHEL Candidates:**

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

**Direct Client Care:**

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey  
First Act:**

**Resume Note:**
