<p><b>EDUCATION:</b> Successful completion of 60 semester hour credits from an accredited college or university which shall have included 24 semester hour credits in the biological and/or physical sciences.</p> <p><b>NOTE:</b> Successful completion of a certificate program in Clinical Laboratory Technology may be substituted for the above education.</p> <p><b>NOTE:</b> Applicants who do not possess the required credits or certificate in Clinical Laboratory Technology may substitute two (2) years of experience as a technician in a public health, hospital, clinical, or research laboratory performing bacteriological, chemical, histological, serology, and/or virological tests.</p> <p><b>LICENSE:</b> Appointee will be required to possess a driver'S license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.</p>

**PHEL Candidates:**

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

**Direct Client Care:**

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.

**New Jersey  
First Act:**

In accordance with N.J.S.A. 52:14-7, the "New Jersey First Act", all employees must reside in the State of New Jersey, unless exempted under the law. If you do not live in New Jersey, you have one year after you begin employment to relocate your residence to New Jersey.

**Resume Note:**

Applicants who possess foreign degrees (degrees earned outside of the U.S.) are required to provide an evaluation indicating the U.S. equivalency prior to the closing date. Failure to do so may result in your ineligibility.

**Authorization to Work:**
