### GENERAL DESCRIPTION

**PHEL Candidates:**

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

The cost of any pre-employment testing will be at the candidate's expense.
