	•	GENERAL DESCRIPTION	ON

Under the direction of the Executive Director of New Jersey Early Intervention System (NJEIS) or a higher-level supervisor, this position will be tasked with the oversight and execution of NJEIS programs. The role requires the development and management of program activities that facilitate early identification, support, and management of children at risk for or diagnosed with chronic disabilities, including autism and other developmental challenges. The Program Manager is responsible for directing surveillance projects, research studies, and early screening initiatives, ensuring compliance with guidelines and effective delivery of services. The Program Manager will lead a team, including the NJEIS monitoring group and data analysts, supervising and training staff to optimize program delivery. Collaboration with stakeholders, development of training materials, liaising with federal agencies, staying updated on research, overseeing health grant applications, budgeting, and report preparation are also key components of this position. The goal is to enhance the quality and efficacy of NJEIS services, supporting the health and development of children with chronic conditions.

REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

NOTE: Applicants must meet one of the following or a combination of both experience and education. Thirty (30) semester hour credits are equal to one (1) year of relevant experience.

Nine (9) years of professional experience in any of the following areas: program management and administration, program research and development, resource planning, and budgeting and staffing, two (2) years which shall have been in a supervisory capacity.

OR

Possession of a Bachelor's degree from an accredited college or university; and five (5) years of the above-mentioned professional experience, two (2) years which shall have been in a supervisory capacity.

Possession of a Master's degree in Public Health, Public Administration, Business Administration, or a related health area; and four (4) years of the above mentioned professional experience, two (2) years of which shall have been in a supervisory capacity.

NOTE: "Professional experience" refers to work that is creative, analytical, evaluative, and interpretive; requires a range and depth of specialized knowledge of the profession's principles, concepts, theories, and practices; and is performed with the authority to act according to one's own judgement and make accurate and informed decisions.

Direct Client Care: If you are a candidate for a position that involves direct client care in one of
