		GENERAL DESCRIPTION	ON

The Board-Certified Psychiatrist is an integral member of the treatment team, providing clinical expertise, diagnosis, treatment, and court-ordered evaluations. In this role, you will admit and discharge patients to and from the hospital; provide expert court testimony concerning patients. It is vital that there are psychiatrists available twenty-four hours a day, seven days a week to provide clinical services to the patients. This position will serve in the role of Medical Doctor on Duty (MOD), working second and third shifts (i.e. "after hours") on weekdays, as well as on weekends and holidays, and will play a necessary and important role in patient care. Will be assigned to MOD duties. This is a full-time position that will include occasional weekday overnight coverage (4:00 p.m.-8:00 a.m), and a combination of daytime and evening and/or overnight hours on weekends and holidays.

#### REQUIREMENTS (EDUCATION / EXPERIENCE / LICENSES)

CERTIFICATION: Possession of current certification as a diplomate in the specialty of psychiatry issued by the American Board of Psychiatry and Neurology.

LICENSE: Possession of an Unrestricted License to practice medicine in the State of New Jersey.

Possession of an unrestricted State of New Jersey Controlled Dangerous Substances License.

Possession of an unrestricted Drug Enforcement Agency (DEA) Registration number.

Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.

**PHEL Candidates:** 

If you are a candidate for a position in our Public Health and Environmental Laboratories, you may be subject to pre- and /or post-employment alcohol and drug testing.

**Direct Client Care:** 

If you are a candidate for a position that involves direct client care in one of the State facilities/programs, you may be subject to pre- and/or post-employment drug testing/screening. The cost of any pre-employment testing will be at the candidate's expense. Candidates with a positive drug test result, or those who refuse to be tested and/or cooperate with the testing requirement, will not be hired.
