### **Preface**

Each of New Jersey's 31 public institutions of higher education is required to submit an annual report to the New Jersey Office of the Secretary of Higher Education that addresses several performance indicators. Submission of this report, entitled the Annual Institutional Profile (AIP), fulfills the mandate of state statute N.J.S.A. 18A:3B-43 to prepare and make available to the public an annual report on the condition of the institution. The form and content of the AIP is established by the Office of the Secretary of Higher Education. The Appendix contains the specific form and content required for the 2020 Profiles.

Situated in six locations in Monmouth County, Brookdale Community College offers degrees designed to transfer to four-year institutions, as well as degrees and certificates which prepare students to enter the workforce directly. Brookdale is proud to consistently rank among the top 100 degree producers out of all two-year public community colleges.

The Annual Institutional Profiles include a wide variety of Indicators such as accreditation status, number of credit and noncredit students served, academic preparedness of entering students, number of degrees conferred, graduation, transfer and retention rates, percentage of course sections taught by full-time faculty, characteristics of the Board of Trustees (e.g., race/ethnicity and affiliation), public service activities, degree and certificate programs offered, and major capital projects in fiscal year 2020.

As such, Brookdale's Annual Institutional Profile provides a summary of many of our fiscal year 2020 accomplishments and contributions to our community. # SECTION A ACCREDITATION STATUS

#### INSTITUTIONAL ACCREDITATION

Brookdale Community College is accredited by the Commission on Higher Education of the Middle States Association of Colleges and Schools, the accrediting agency for all colleges in the mid-Atlantic region. The Commission on Higher Education is an institutional accrediting agency recognized by the U.S. Secretary of Education and the Commission on Recognition of Postsecondary Accreditation.

Brookdale is certified by the State of New Jersey and the United States Department of Education to grant associate degrees to students who complete formal programs of study. All of Brookdale's associate-degree programs are approved by the State of New Jersey Office of the Secretary of Higher Education.

### PROFESSIONAL ACCREDITATION

The Culinary Arts AAS program is accredited by the American Culinary Federation Education Foundation's (ACFEF) Accrediting Commission.

The Human Services program is accredited by the Council for Standards in Human Service Education.

The Nursing program is accredited by the Accrediting Commission for Education in Nursing (ACEN) and by the New Jersey Board of Nursing (NJBON).

The Radiologic Technology program is accredited by the Joint Review Committee on Education in Radiologic Technology (JRCERT) and the New Jersey Radiologic Technology Board of Examiners.

The Respiratory Care Program is accredited by the Committee on Accreditation for Respiratory Care (CoArc).

### PROGRAM RECOGNITION OR CERTIFICATION

The GM-ASEP option of the Automotive Technology program is certified by the National Automotive Technicians Foundation (NATEF).

The Paralegal Studies program is approved by the American Bar Association, Standing Committee on Paralegals.

#### 1. How many full and part time credit students were enrolled in Fall 2019?

#### 2. How many non-credit students were served in FY 2019?

There were close to 11,000 registrations (10,737) in Brookdale non-credit open-enrollment courses in FY 2019, representing 6,775 different individuals. Approximately 1 out of every 3 enrollments (3,483 or 32.4%) were in career-oriented or vocational courses and 2 out of 3 (7,254 or 67.6%) registrations were in leisure or recreational courses. The 10,737 registrants in non-credit open-enrollment courses enrolled for 307,796.0 clock hours or 684.0 FTEs.

There were also **2,475** registrations in courses offered through Contracted Services in FY 2019. Two hundred and ten courses were delivered to **164 companies**, resulting in 39.2 training FTEs. In addition, there were **2,831** registrations in courses offered through Contracted Services to local schools. Forty-eight sections were delivered to **52 schools**, resulting in 15.7 FTEs.

### 3. How many credit students enrolled in Fiscal Year 2019?

The unduplicated credit enrollment for FY 2019 was 17,100. These students enrolled for a total of 256,472.5 credits or 8,549.1 FTEs between the Summer III 2018 term and the Summer II 2019 term.

# SECTION C CHARACTERISTICS OF UNDERGRADUATE STUDENTS

### FOUNDATIONAL STUDIES TESTING AND REMEDIATION

## 1. What Foundational Studies placement test does Brookdale use? What criteria are used for selecting test takers?

Brookdale Community College transitioned from the Classic Accuplacer computerized adaptive placement test (CPT) to the Accuplacer Next Generation test in October of 2018. The Accuplacer Next Generation tool includes sections on Reading, Writing, Arithmetic, and Quantitative Reasoning, Algebra and Statistics.

All new degree-seeking students must take the Foundational Studies Placement Test or be waived from testing. Waivers of testing are available to the following students: (1) Those who have completed at least 24 college level credits with a grade of "C" or better at an accredited institution. The 24 credits must include English Composition and a mathematics course higher than Elementary Algebra. (2) Those who have taken the Accuplacer Classic or Next Generation test at another college. (3) Those with a four-year degree from an accredited college. (4) Students who have taken the SAT and have scored 480 or higher on Evidence Based Reading and Writing (ERW) and 530 or higher on Math. (5) Students who have taken the new ACT and have scored 23 or higher on Reading, 22 or higher on Math, and 8 or higher on Writing. (6) Non-native speakers of English. (7) Individuals 65 and older. In addition, the College used a variety of waivers for the incoming Fall 2020 cohort (e.g., high school transcripts, PSAT scores) due to the inability to test remotely using Accuplacer.

#### 2. How many Fall 2019 students were enrolled in one or more Foundational Studies courses?

Of the 11,489 students enrolled in Fall 2019, 1,821 (15.8%) were enrolled in at least one Foundational Studies course.

## 3. How many first-time, full-time (FTFT) degree-seeking students were enrolled in Foundational Studies courses in Fall 2019?

Of the 1,729 first-time, full-time, degree-seeking students enrolled in Fall 2019, 797 (46.1%) were enrolled in at least one Foundational Studies course.

### **RESIDENCY**

### 1. What percentage of the student body are New Jersey residents?

- Among Brookdale's 11,489 Fall 2019 students, 11,309 (or **98.4%**) were New Jersey residents. Of these, 10,149 (or **89.7%**) were Monmouth County residents.
- Among Fall 2019 first-time, degree-seeking students (2,132), **98.5%** (or 2,100) were New Jersey residents, of whom 1,870 (or **89.0%)** were living in Monmouth County.

# SECTION D STUDENT OUTCOMES – GRADUATION, RETENTION AND TRANSFER



### 1. What percentage of full-time freshmen graduate or transfer within 3 years?

The figures below reflect *3-year* graduation and transfer rates for first-time, full-time matriculated students. The transfer rates include National Student Clearinghouse data on transfers to most baccalaureate-granting institutions. The reported transfer rates refer only to those students who *did not* graduate within 150% of time to degree completion. More specifically, if a student graduated within three years and then transferred to another institution, (s)he would be identified only in the graduation rate and not in the transfer rate. The data below have been reported on the annual Federal Graduation Rate Survey (GRS). On the Graduation Rate Survey, students have until the end of the Summer of their 3<sup>rd</sup> year to either graduate or transfer to another institution (e.g., members of the Fall 2016 cohort had until the end of Summer 2019 to graduate or transfer).

# SECTION F CHARACTERISTICS OF THE TRUSTEES OR GOVERNORS

The Trustees of Brookdale Community College are dedicated members of the Monmouth County community. The Board is comprised of 12 Monmouth County citizens who serve in four-year terms. Two members are ex officio: Brookdale President Dr. David Stout (a non-voting member) and Interim Executive County Superintendent of Schools, Dr. Les Richens. Two members are appointed by the Governor and eight are appointed by the Monmouth County Board of Chosen Freeholders. The Graduate Trustee is chosen by his or her graduating peers.

**Ms. Tracey Abby-White** is Board of Trustees Chair and Chair of the Executive Committee. She is an exofficio member of all Board committees and is on the Board of School Estimate team. Ms. Abby-White, the Director of Sales Enablement at a global network security company, was appointed to the Board in 2013 and was reappointed in 2016. **Dr. Henry Cram**, Vice Chair of the Board and of the Executive Committee, was appointed to the Board in November 2014 and was reappointed in 2018. Dr. Cram is Chair of the Finance & Facilities Committee and serves on the Student Success & Educational Excellence Committee. Dr. Cram is also on the Board of School Estimate Team.

**Mr. Daniel Becht, Esq.**, is a member of the Governance and Audit Committees. Mr. Becht was appointed to the Board of Trustees in March 2017 and practices law at his own firm. **Ms. Suzanne Brennan, Esq.**, chairs the Governance Committee and is a member of the Executive Committee. Ms. Brennan was appointed to the Board in 2017 and practices law at her own firm.

**Mr. Paul Crupi**, a member of the Audit Committee, joined the Board in 2014 and was reappointed in 2018. Mr. Crupi is Senior Vice President of a public affairs and business development firm. **Ms. Dyese Davis**, was appointed to the Board by the Governor in June 2020. She serves on the Governance Committee and the Finance & Facilities Committee. Ms. Davis is Deputy Chief of Staff to a New Jersey State Senator.

**Ms. Madeline Ferraro, Esq.** was appointed to the Board in November of 2016 by the Governor and serves on the Finance & Facilities Committee. Ms. Ferraro is Vice President of Government and Public Affairs at a health care services organization. **Ms. Barbara Horl** is the Liaison to the New Jersey Council of County Colleges (NJCCC), is a NJCCC Trustee Ambassador and serves on the Student Success & Educational Excellence Committee. Ms. Horl joined the Board in April 2019.

**Mr. Francis Bret Kaufmann,** founder of his own consultation and evaluation firm, was appointed to the Board in November 2015 and reappointed in 2019. Mr. Kaufmann chairs the Student Success & Educational Excellence Committee and is a member of the Executive and Finance Committees. **Ms. Marta Rambaud** is Chair of the Audit Committee and serves on the Executive and Governance Committees. Ms. Rambaud is an engineer, professor and physics teacher who joined the Board in May 2016 and was reappointed in 2019.

**Dr. Lester W. Richens,** Interim Monmouth County Executive School Superintendent, was appointed to the Board in April 2015. Dr. Richens serves on the Finance & Facilities Committee and the Student Success & Educational Excellence Committee. **Ms. Hanna Walker**, Brookdale's Graduate Trustee, was sworn in to the Board in July 2020. Ms. Walker is a member of the Governance Committee and the Audit Committee. Ms. Walker is a student, a retail sales associate, and administrative assistant at the Hazlet Environmental Commission.

# SECTION G A PROFILE OF THE INSTITUTION

#### 1. Provide a profile of Brookdale's degree and certificate programs.

Brookdale Community College has a main campus in the Lincroft section of Middletown and several regional locations throughout Monmouth County – Eastern Monmouth (*Brookdale at Neptune*), Northern Monmouth (*Brookdale at Hazlet*), Western Monmouth (Brookdale at Freehold), Wall and Long Branch. Brookdale offers AA, AFA, AS, and AAS degrees in 68 programs including options. Brookdale also offers four Academic Credit Certificates (ACC) that require 30 or more credits to complete, as well as 8 Academic Credit Certificates of Achievement (ACA) which require fewer than 30 credits to earn.

The table on pages 15-16 contains the degree and certificate programs currently offered at Brookdale Community College. In the table, degree programs are presented first and are listed alphabetically. Certificate programs follow.

Brookdale also provides degree pathways from associate degree through graduate level courses through in-county partnerships with Georgian Court University, New Jersey City University, and Rutgers, the State University of New Jersey. University Partnerships allow Monmouth county residents to pursue multiple degree options without having to leave the county.

**The Brookdale - Georgian Court University Partnership** is located at *Brookdale at Hazlet*, and offers bachelor's degrees in Business Administration, English, Interdisciplinary Studies, and Psychology, plus a teacher certification program. RN to BSN, BSW-Social Work and MBA programs have also been recently added.

**The Brookdale - New Jersey City University Partnership** is located at Brookdale's Wall campus and serves as home to NJCU's ten available bachelor's degree programs and four graduate programs, including MBA, the accelerated Bachelor of Science in Nursing (BSN) second degree program, MS Nursing Education, and Graduate School Nurse Certificate.

**The Brookdale - Rutgers University Partnership** is located on Brookdale's main Lincroft Campus. This growing partnership continues to offer a wide range of undergraduate degree classes and degree programs; Rutgers currently offers nine bachelor's degree programs through the partnership, with additional programs in the works.

All three partnerships offer university-level courses taught by university faculty at one convenient Brookdale location. Students receive a bachelor's or master's degree from the partner institution, and can utilize many of the services and support offered to traditional university students. Many degree programs also offer dual admissions, streamlined transfer agreements and other benefits to Brookdale graduates.

# SECTION H RESEARCH AND PUBLIC SERVICE ACTIVITIES

### 1. Provide examples of research and public service activities at your institution.

<u>Brookdale Volunteer Connection.</u> The Employee Volunteer Connection is a group of Brookdale Community College employees, retirees and community members dedicated to helping families in need in Monmouth County. They help connect colleagues and students with community service projects. Each year, the Volunteer Connection identifies several Monmouth County agencies or important causes, and emphasizes their needs through an email distribution list, newsletters, campus flyers, and broadcast announcements.

Like many volunteer groups in the country, the Brookdale Employee Volunteer Connection was unable to carry out many of its usual activities this year due to COVID-19. Normally, the Volunteer Connection organizes a variety of projects. The *Empty Bowls* event, which is normally held in Spring, raises money for local food pantries. In partnership with our BCC professors and the use of the ceramics lab, employees and community members create ceramic bowls that are used to help raise funds for the event.

Each summer the Volunteer Connection contributes to *Project Backpack* by donating school supplies to children in the community. This initiative helps students start the school year off right and ready to learn. Together with Follett Books and Brookdale's Helping Hands, Brookdale collects school supplies and partners with Lunch Break to distribute the filled backpacks to area children as well as help our own Brookdale students in need.

In December 2019, the Volunteer Connection organized the annual *Giving Tree*, which was hosted at our Lincroft, Freehold, Wall, Long Branch and Hazlet sites. Brookdale collected and distributed over 400 gifts and dozens of gift cards to families from Family & Children's Services Operation Sleighbell, Visiting Nurses Association (VNA), St. Vincent DePaul and Brookdale's own Helping Hands, Displaced Homemakers and the Brookdale Foundation.

Approximately four times a year, the Volunteer Connection also donates, prepares & serves dinner for the homeless and disabled residents at the *HABCORE* house in Red Bank. Unfortunately, COVID-19 restrictions limited us to hosting only one dinner this year. The Volunteer Connection also provided residents with holiday stockings filled with snacks, toiletries, and games etc. and donated boxed candy for the staff.

Adult Basic Education Programs. Adult Basic Education, GED Preparation, and English as a Second Language classes are available through our regional locations in Hazlet, Long Branch, Neptune and Freehold. In addition, an ESL class that serves as a bridge to the credit ESL program is offered on the Lincroft campus. Due to the COVID-19 outbreak, our GED and ESL classes and services were conducted entirely online. Brookdale is the lead agency for the Monmouth County Adult Education Consortium. Members include Community Affairs and Resource Center, LADACIN Network, Literacy Volunteers, and the Monmouth County Vocational High School.

Brookdale Public Radio (90.5 The NIGHT). WBJB-FM (Brookdale Jersey Blues) is a full-service local public radio station and National Public Radio (NPR) member station. 90.5 The NIGHT is a non-commercial FM public radio station with a staff of professional radio personnel. This member supported radio station has regularly been named as the "Top Radio station in Support of Live Music"

during the annual Asbury Music Awards. Now in its 46<sup>th</sup> year on the air, 90.5 The NIGHT remains dedicated to serving the community by working with local non-profit organizations on many programming ventures and by providing free public service announcements.

Brookdale Television (BTV). Brookdale Television (BTV) is a non-profit educational access channel that provides a "visual bridge" between Brookdale Community College and the communities that it serves. BTV produces high quality educational television and public affairs programs that are broadcast via Comcast (channel 21) and Verizon FIOS (channel 46), effectively reaching most cablewired households in Monmouth County.

Center for Holocaust, Human Rights & Genocide Education (CHHANGE). The Center for Holocaust, Human Rights & Genocide Education is dedicated to providing resources for education on the Holocaust, genocide and human rights. The Center staff works to eliminate racism, anti-Semitism and all forms of prejudice in our society. The Center serves the community through its comprehensive and creative educational programs and resources. Cornerstone programs include: (1) Journeys Beyond Genocide: The Human Experience, an innovative exhibit that engages visitors with the Holocaust, the Armenian Genocide, and the 1994 Genocide against the Tutsi in Rwanda and empowers visitors to Stand Up for Human Rights. (2) Building Bridges, an educational initiative that helps build a culture of mutual respect and understanding—creating a safe, welcoming school community—through in-school programs, field trips to Chhange, and teacher professional development. (3) An annual Colloquium, which welcomes up to 2,500 students and educators to the Brookdale campus for a half-day program that includes a plenary session and 30 breakout workshops. (4) Programs for the general community, including annual scholarly lectures, film series, book discussions, testimony from Holocaust and genocide survivors, and collaborative programs with the Monmouth County Prosecutor's Office and the United States Holocaust Memorial Museum in the training of law enforcement officers. Due to the pandemic, Chhange transitioned in March 2020 to virtual programming, reaching over 24,000 people spanning across five continents.

The Center for World War II Studies and Conflict Resolution. The Center is dedicated to fostering the study of the historical, political, social, economic, cultural and military aspects of the World War II era up through the Korean War. The Center educates the community about the era and its impact on world history and helps future generations avoid armed conflict in the resolution of global problems. The ultimate goal of The Center is to utilize the lessons learned from the World War II era to prevent the recurrence of global armed conflict in a world of sovereign states with divergent interests, wants and needs. The Center is a resource open to all, offering educational programs and community presentations.

The Displaced Homemakers Program. Brookdale Community College's Displaced Homemakers program provides assistance to those who have lost their primary source of income due to separation, divorce, disability, domestic violence, or death of a spouse or long term partner. Services include personal coaching and mentoring, job search classes, resume assistance, career guidance, job leads, computer classes, workshops on relevant topics, internal Brookdale and community resources and referrals, and possible sponsorship in certificate training classes. Most of these services are offered at Brookdale's Long Branch location. These services are primarily funded by the New Jersey Department of Children and Family Services Division on Women along with financial and in-kind support from Brookdale.

The Brookdale Foundation. In FY19, the Brookdale Foundation provided \$841,031 in scholarships, grants and other programs and projects that support student success. This represents an increase of \$127,976 over FY18 funding. More than 650 students received scholarships and grants, a nine percent increase over the previous year. Scholarships are awarded to students having financial need (the majority do not qualify for Federal or State grants) and who meet other established criteria. Other grants are provided to faculty, staff, and departments for projects that enhance educational services,

address student's basic needs and increase access for students, including the POSEIDON Early College High School in Neptune and the Asbury College Promise program. The Foundation also paid for the replacement of 110 computers in the Bankier Library.

Free Tuition for Unemployed Persons, Volunteer Firefighters, Volunteer First Aid Workers, and Family Dependents of 9/11. The Unemployed Persons Tuition Waiver program requires colleges to admit people who can demonstrate that they are unemployed. Free tuition is also granted to volunteer firefighters and first aid workers. In each of these programs, students are admitted to classes on a seat-available basis and they are responsible for all fees. In response to the tragic events of September 11, 2001, Brookdale also provides Monmouth County's surviving spouses and dependent children of victims with free tuition.

Youth GED & Career Pathways Program. The Youth GED Program offers free exam preparation classes and tutoring (for eligible students, ages 16 to 24 years old) at Brookdale's regional locations in Hazlet, Long Branch, Neptune, and Freehold. Upon successful completion of the four exams, students receive their High School Equivalency Diploma issued by the NJ Department of Education. The program also provides assistance with career exploration, securing employment, enrolling in post-secondary education, and entry into the armed forces. Due to the COVID-19 outbreak, services are offered online.

Monmouth County Division of Social Services. A bilingual social worker is available on the Lincroft campus two days a week. The social worker provides information and referrals to a variety of programs administered by the Monmouth County Division of Social Services, as well as assistance in navigating agency benefits and programs such as SNAP (food stamps), utility assistance, housing assistance, and Medicaid.

New Jersey Small Business Development Center. The New Jersey Small Business Development Center (NJSBDC) at Brookdale Community College provides counseling and workshops to the business community of Monmouth and Ocean counties. Courses, workshops and conferences are designed to give owners, potential owners and managers the tools to analyze and resolve business problems and to keep up to date with educational, research, financial and international trade developments. All NJSBDC programs are presented by highly qualified specialists, including faculty, private consultants, business owners and government representatives. NJSBDC at Brookdale Community College is funded in part through a cooperative agreement with the U.S. Small Business Administration (SBA). The NJSBDC is the leading provider of small business consulting and management services, and is a non-profit, federal-state-educational partnership.

# SECTION I MAJOR CAPITAL PROJECTS

### Major Capital Projects / Improvements (Academic Year 2019 - 2020)

During the Academic Year 2019-2020, the following capital projects and improvements were undertaken at Brookdale Community College.

**Acoustical Sound Barrier:** The College expended \$49,550 for the installation of a sound barrier wall related to the Wall building rooftop chillers.

**Acoustic Wall:** The cost for the folding acoustic doors in the Advanced Technology (ATeC) building was \$23,840.

**ADA Door Replacement:** Architectural and Engineering services and contractor fees for the ADA-compliant door replacements at the Lincroft Campus were \$465,603 for Phase I and \$30,750 for Phase II.

**Athletic Fields Renovation / Upgrade:** During the course of the year, Brookdale expended \$2,227,989 for the rehabilitation of the soccer, softball and baseball fields.

**Bathroom Renovation**: The College paid \$9,789 to renovate single use bathrooms in the Main Academic Complex (MAC) and Main Academic North (MAN) buildings at Lincroft.

**Boiler Replacement:** The cost of replacing the boiler at Brookdale's Freehold location was \$75,600.

Carpeting and Flooring Replacement: The College expended \$68,159 on the installation of flooring and carpeting in the following Lincroft locations: ATeC, Bankier Library, Center for Visual Arts (CVA), Counseling, Admissions and Registration (CAR), Main Academic South (MAS), and Student Life Center (SLC),

**Chiller Replacement:** The replacement of the chiller equipment at the CVA and Larrison Hall (LAH) buildings cost the College \$42,271.

**Classroom Projectors:** Brookdale spent \$25,821 on the electrical upgrades for new projectors and installation of new whiteboards in various classes.

**Electrical Upgrades:** The College expended \$25,085 in electrical upgrades for the electrical panel and light pole at the Lincroft campus (\$19,576) and for a dedicated circuit in the Nursing department in MAS (\$5,509).

**Elevator Modernization:** The cost to upgrade the elevators in the ATeC building at Lincroft and in the Freehold building was \$30,216.

**Gas Heater Replacement:** The replacement of the gas heater at the Arena cost the College \$31,100.

**HVAC Upgrades:** Brookdale expended \$626,063 on the following HVAC upgrades throughout FY20:

- Architectural and Engineering and Construction fees for the replacement of HVAC in the Brookdale Administrative Center (BAC; \$500,319).
- OIT switch rooms located throughout the Lincroft Campus (\$61,999).
- CVA, Library, MAS and MAN Buildings (\$39,033).

Replacement of rooftop units at the Print Shop (\$24,723).

**Infrastructure Improvements:** During the course of the year, \$68,343 was spent on various equipment upgrades at the Lincroft, Freehold and Wall sites. They are as follows:

- Replacement of pumps at ATeC, Library, and MAS (\$22,855).
- Replacement of a compressor and fan at the Freehold location (\$14,058).
- Replacement of air dampers at the Arena and Library (\$11,868).
- Replacement of snow guards on the ATeC building (\$9,203).
- Replacement of a hot water heater at MAN (\$5,745).
- Installation of a concrete pad for the new generator at the Police Station at the Lincroft Campus (\$3,329).
- Installation of a new fence at the Wall location (\$1,285).

**LED Lighting Improvements:** The College expended \$916,030 for Architectural and Engineering services and Contractor fees for the replacement of lighting, including emergency lights and wall packs throughout the College. This project is based on the New Jersey CleanEnergy program and will result in a rebate for the College.

Life Safety: Brookdale spent \$305,402 on a number of Life Safety projects throughout the year.

- Professional engineering services and installation for the completion of Phase II of the Fire Alarm upgrades to replace the existing discontinued IRC3 fire alarm panels with EST-3 panels. The discontinued panels were located in the following buildings on the Lincroft Campus: Children's Learning Center (CLC), CVA, MAC, MAS, Maintenance, Police Station, Power Plant, Print Shop and Receiving and Mail Center (\$222,069).
- Completion of the upgrade to the Emergency Phones located at the Lincroft Campus. (\$81,033)
- Replacement of a fire door in ATeC (\$2,300).

Paving: The project cost of paving Parking Lots 1 and 2 as well as Campus Drive was \$416,559.

**Relocations:** A total of \$287,380 was spent on two relocation projects.

- The Testing Center was relocated to the Bankier Library (\$196,330).
- The Massage Therapy program was moved to the CAR building (\$91,050).

**Roof Replacement:** A number of roof replacement projects were undertaken during the year. The total cost for these projects, which are listed below, was \$848,141.

- Architectural and Engineering services to develop the bid specifications for the total cost of the removal and replacement of the roof at Freehold (\$24,250).
