Preface

Hudson County Community College (HCCC) is a vibrant, comprehensive, urban college providing highquality programs and services that promote student success and upward social and economic mobility. It is the largest institution of higher education in Hudson County, serving one of the most historic, densely populated, and ethnically diverse areas of the United States. Courses are available at three state-of-the-art campuses - the Journal Square Campus in Jersey City, North Hudson Campus in Union City, and the Secaucus Center in Secaucus, all easily accessible by public transportation - in addition to a diverse and growing array of fully online programs.

In 1974, the New Jersey Board of Higher Education established a community college commission in Hudson County. HCCC began as a "contract college." In the mid-1990s, HCCC formulated and began implementing strategic plans for its academic and physical growth focused on community needs. The administration and Board of Trustees worked to ensure that all of the people of Hudson County had access to a high-quality, affordable education that provided the knowledge and skills needed in today's complex, global society. The goals of that plan were accomplished, the College achieved growing stability in enrollment, resources, and operations over time.

Going forward, the "Building the Future," "Building on Success," and "An Institution of First Choice" strategic plans were successfully implemented. These plans brought the College remarkable growth, including increased enrollment and graduation rates and physical expansion.

HCCC is close to completion of its most recent strategic plan, entitled "Hudson is Home!" The "Hudson is Home!" Strategic Plan is focused on two overarching College priorities: Student Success, and Diversity, Equity, and Inclusion. As the College looks towards its next Strategic Plan, these priorities will pervade HCCC's Academic Plan, Student Success Action Plan, DEI Action Plan, Board of Trustee Goals, and Presidential Goals.

HCCC has designed and implemented innovative and award-winning programs addressing the barriers that prevent students from completing their degrees. Our *Hudson Scholars* program, winner of the prestigious 2023 National Bellwether Award for Instructional Programs and Services and the 2024 National Bellwether Legacy Award, combines proactive academic advisement, financial stipends, high impact educational experiences, and early academic intervention to drive student success.

Hudson Scholars has increased student success across the board, improving a student's likelihood of persisting by roughly 30%, while cutting time-to-completion in half. The program has been especially impactful for students from traditionally underrepresented groups including Hispanic and African-American students. Hispanic and Latino participants in the program are 52% more likely to persist and 363% more likely to graduate in two years in comparison to students who are not in the program. In Fall 2023 the program introduced an innovative faculty mentoring component to assist third-year students in completing their degrees and help prepare them for further study or the workforce. To date, Hudson Scholars has served over 3,600 students, and the College is expanding this best-practice model to all credential-seeking students.

HCCC has experienced unprecedented growth in its course offerings, created the nationally distinctive "Hudson Helps Resource Center" with wraparound services to support students, joined the *Achieving the Dream* network of high-performing community colleges committed to the use of data and best practices to inform student success, and created the President's Advisory Council on Diversity, Equity and Inclusion and a Vice President for DEI, reporting to the President, to lead and support diversity, equity and inclusion in all forms. These efforts have galvanized the HCCC and external communities and have brought HCCC growing regional, state-wide, and national recognition and commendation.

This work is integrated into a foundation of college-wide initiatives such as a comprehensive and centralized academic and student success counseling program, expanded and enhanced student activities and cultural programs including an art gallery and year-round cultural programs open to the community, and the continued development and expansion of state-of-the-art facilities.

In alignment with HCCC's commitment to removing barriers, supporting the needs of all learners, and promoting equitable outcomes for all students, the College has invested significant funding, including state and federal stimulus dollars, into enhanced classroom technology. New and improved college-wide technology includes comprehensive, immersive telepresence video systems, microphones, document cameras, special whiteboards, and virtual desktop infrastructure with the goal of facilitating a high-quality, robust educational experience for all students.

In addition to day and evening classes, the College now provides on-campus studies seven days a week and a growing and comprehensive array of virtual and online courses, programs, and services 24/7.

2 ACCREDITATION STATUS

2.1 INSTITUTIONAL ACCREDITATION

Hudson County Community College is an Accredited institution and a member of the Middle States Commission on Higher Education (MSCHE or the Commission) www.msche.org. Hudson County Community College's accreditation status is Accreditation Reaffirmed. The Commission's most recent action on the institution's accreditation status on June 27, 2019, was to reaffirm accreditation.

MSCHE is recognized by the U.S. Secretary of Education to conduct accreditation and pre-accreditation (candidate status) activities for institutions of higher education including distance, correspondence education, and direct assessment programs offered at those institutions. The Commission's geographic area of accrediting activities is throughout the United States.

2.2 PROFESSIONAL ACCREDITATION

The AAS degrees in Culinary Arts and Culinary Arts-Option in Baking and Pastry and the Certificates in Culinary Arts and Culinary Arts-Baking and Pastry are accredited by the Accrediting Commission of the American Culinary Federation Education Foundation.

The Medical Assisting program is accredited by the Commission on Accreditation of Allied Health Education Program upon the recommendation of the Medical Assisting Education Review Board (MAERB) on Accreditation.

The Nursing (NSG) Program currently offered at the Journal Square Campus is approved by the New Jersey Board of Nursing and accredited by the Accreditation Commission for Education in Nursing (ACEN).

The Practical Nursing (PNU) Program offered at the Journal Square Campus is sanctioned by the New Jersey Board of Nursing.

The Paramedic Science (EMT) Program is offered in conjunction with Robert Wood Johnson/Barnabas Health at the Jersey City Medical Center. It is accredited by the Commission on Accreditation of Allied Health Education Programs upon the recommendation of the Committee on Accreditation of Educational Programs for the Emergency Medical Services Professions (CoAEMSP).

The Radiography Program is accredited by the Joint Review Committee on Education in Radiologic Technology (JRCERT) and approved by the New Jersey Radiologic Technology Board of Examiners.

9 RESEARCH AND PUBLIC SERVICE ACTIVITIES

9.1 GRANTS AND RESEARCH

Led and supported increased grant seeking activities across the college leading to increased levels of grant funding awards and dollars received. Nearly \$5 million in grant funding was awarded to HCCC projects in 2023-24, compared to \$2.8 million in the previous year. Additional proposals have been submitted and await funding decisions. Highlights of new grants awarded include the following.

- HCCC held its 26th Annual HCCC Foundation Gala in December 2023. More than 200 friends of the College gathered for the celebration that raised more than \$200,000 for student scholarships. The Schools of CEWD, STEM, Humanities and Social Sciences, and Nursing and Health Professions evening's success with academic and program displays. 25 faculty from the School of Business, Culinary Arts and Hospitality Management joined 90 students and 10 alumni in preparing and hosting the event.
- Forest Hill Field Club was the site for the HCCC Foundation's Annual Golf Outing an event that engages the community for a day on the links to raise funds that support student scholarships and contribute to the College and Foundation's mission.
- The National Science Foundation (NSF) awarded \$600,000 to HCCC's Cybersecurity Center and program. The grant will promote gender equity across courses and curricula and support significant enhancements of HCCC cybersecurity classroom labs to provide students with industry-informed, hands-on practical experiences. Leading this project are Dean of STEM Dr. Burl Yearwood and STEM Professors Faisal Aljamal and Yavuz Guner. This is HCCC's second NSF grant, and a third proposal to NSF is in development.
- The United States Department of Labor awarded \$1.75 million to HCCC's School of Continuing Education and Workforce Development (CEWD). The four-year project funding will help create career pathways in the financial services and technology sectors. This is a significant and longsought achievement for Associate Vice President for Continuing Education and Workforce Development Lori Margolin, Workforce Pathways Director Anita Belle, Gateway to Innovation Associate Director Laurice Dukes, and their teams.
- The New Jersey Department of Labor and Workforce Development awarded \$216,000 to HCCC's School of CEWD to support Pre-Apprenticeships in Career Education (PACE) and \$72,000 to

support Growing Apprenticeships in Nontraditional Sectors (GAINS) projects in partnership with Eastern Millwork, Inc. and our HCCC-EMI Holz Technik apprenticeship program, hailed by NJ Governor Phil Murphy as the blueprint for New Jersey's economic future.

- The College was awarded its annual grant under the federal Perkins V program (Strengthening Career and Technical Education for the 21st Century Act, named in memory of vocational education advocate and Congressman Carl D. Perkins). The NJ Department of Education allocated \$1.4 million to HCCC for 2023-24 to support the College's career and technical education programs and initiatives.
- Provident Bank Foundation selected HCCC to receive its largest gift award of \$100,000 last year for the nationally recognized Hudson Scholars program. The program is led by Associate Dean Gretchen Schulthes and Assistant VP John Urgola.
- The Aspen Institute awarded \$50,000 to CEWD in support of the postsecondary Success for Parent Initiative (SPI).
- The Citizens Bank Foundation awarded \$25,000 in support of the CEWD Gateway to Innovation program.
- The Tepper Foundation, in collaboration with the New Jersey Council of County Colleges (NJCCC), awarded \$80,000 to the Hudson Helps Resource Center (HHRC) to provide support for students' basic needs, such as housing, food, and childcare. The project is led by Center's Director, Katherine Morales.
- The HHRC hosted its inaugural HHRC Career Closet Fashion Show, a fundraising event sponsored by top designer Steve Madden. The evening included faculty, staff, and students who walked the runway wearing garments such as those available to students in the HHRC Career Closet – a collection of garments – all new – to help students dress for success as they enter the job market.
- The New Jersey Department of Environmental Protection awarded \$109,000 through the Trees for Schools Program for HCCC tree plantings and landscaping. This project is led by Executive Director of Engineering and Operations Ilya Ashmyan.
- The New Jersey Council for the Humanities awarded \$15,000 to launch the Hudson Oral Histories Project. Led by Associate Professor of History Antonio Acevedo and Assistant Professor of English Sean Egan, this pilot project focuses on the history and impact of gentrification in Jersey City. The project has a number of grants under consideration to build upon the first year's success.
- The Jersey City Arts and Culture Trust Fund awarded \$13,000 to the HCCC Foundation Art Collection to support the creation of descriptive placards for the collection. This project is led by Collection Curator Dr. Andrea Siegel.
- The HCCC Foundation Art Collection received many donations of artwork, bringing the collection to more than 2,000 objects. Recent gifts include works by major Impressionist artists Auguste Renoir, Camille Pissarro, and Henri de Toulouse-Lautrec and important contemporary paintings by d Robert Natkin and Richard Anuszkiewicz. In addition, the Collection also received a gift of 41 ancient objects and artifacts from Egyptian, Etruscan, Eskimo, African, and other cultures. All these works are installed on campus.
- Additional activities and achievements of the HCCC Foundation Art Collection include the following: Dr. Andrea Siegel participated in an Ethical Schools podcast about art and education in April 2024; Brazilian filmmaker shot a documentary short film about HCCC's installation of

the Jailbirds Project by Henrietta Mantooth; a drawing in the Collection by Francisco Zuniga was published by the Museum of Modern Art (MoMA) – a first for the Collection; and articles about the Collection were published in nj.com, Around the Regions Community College National News Roundup of the Association of Community College Trustees (ACCT), and the River View Observer published an article about the Collection's African American art for Black History Month.

- The HCCC Art Collection was opened to the public through several tour events, including the 34th Annual Jersey City Art & Studio tour, a guided tour for Art Leaders of America in partnership with Mana Contemporary, and during the March 2024 Night of Ideas event co-curated by Villa Albertine and Centre Pompidou and hosted by HCCC.
- On behalf of Ascend Parent Advisors, the Aspen Institute selected HCCC to receive a \$50,000 Parent-Powered Solutions Grant one of only six institutions nationally to receive the award.
- Dean of STEM Dr. Burl Yearwood, Assistant Professor of Computer Science Faisal Aljamal, and Instructor of Computer Science Yavuz Guner in their leadership was awarded \$600,000 National Science Foundation (NSF) Grant, entitled "Nurturing Resilience in Hudson County: Empowering the Next Generation of Cybersecurity with a Focus on Women."
- In spring 2024, Professor and artist Laurie Riccadonna received an Individual Artist Fellowship Grant from the Jersey City Arts and Culture Trust Fund and a Jersey City Arts Council Elevation Grant for her work and her contributions to the local art community.
- HCCC was awarded a \$1 million federal Congressionally Directed Spending (CDS) grant to expand upon the College's landmark Hudson Scholars program owing to the efforts of Vice President Dr. Nicholas Chiaravalloti, Senior Vice President Dr. Lisa Dougherty, and colleagues.
- HCCC received \$200,000 as part of the Some College, No Degree initiative of the NJ Office of the Secretary of Education to re-engage students who have begun college but not yet completed their degree.

9.2 New and Ongoing Institutional and Community Partnerships

- HCCC continues its participation in *FamilyU*, a program of the national nonprofit student parent support organization, Generation Hope. Our work over the next two years will focus on the use of data, best practices, and professional development to enhance the retention and completion of HCCC's many student parents.
- The HCCC Center for Adult Transition is funded by the State of New Jersey to support the transition of individuals with intellectual and developmental disabilities up to the age of 24.
- The HCCC Latino Advisory Council and African American Outreach Committee continued their work during the past year. The Latino Advisory Council offered its second annual "Hudson es Casa," a Latino Education and Community Fair at the North Hudson Campus in October.
- Hudson County Community College (HCCC) and New Jersey City University (NJCU) have collaborated to design HCCC|NJCU CONNECT, a transformational program that will provide highly visible, inclusive, and barrier-free transfer pathways to guide students and their families from high school, through studies at HCCC, and on to graduation from NJCU. The program will launch in January 2024.
- HCCC hosted a Summer Training Institute for court-involved young adults at the College's Culinary Conference Center. This innovative program provided 175 court-involved young adults,

ages 18-25, with comprehensive job training and industry-recognized credentials that will ready them for a variety of in-demand and family-sustaining careers).

- Hudson County Community College (HCCC) President, Dr. Christopher Reber, and New Jersey Reentry Corporation (NJRC) Founder and Chairman, former New Jersey Governor James McGreevey, announced the establishment of a Phlebotomy Technician Certification program leading to an industry recognized credential from the National Health Career Association (NHA). The program is designed solely for court-involved individuals.
- HCCC hosted its second annual *Teaching and Learning Symposium on Social Justice in Higher Education*.
- The College was the first institution of higher education in New Jersey selected to participate in the health care segment of the Pay It Forward Program. The program provides zero-interest, no-fee loans, non-repayable living stipends, access to emergency aid funds, and supportive services like mental health counseling for students. The HCCC Associate of Science (A.S.) in Nursing program was chosen for its proven, high-quality training, and track record of strong employment outcomes, employer relationships, and experience serving diverse learners. The Pay It Forward Program closely aligns with HCCC's overarching principles of dedication to diversity, equity and inclusion, and student success.
- HCCC was selected by The Tepper Foundation to participate in their "Building Community to Expand Opportunity Initiative," a two-year project offered in partnership with the NJ Council of County Colleges (NJCCC). The project is focused on expanding capacity to meet students' basic needs by strengthening a culture of care. This initiative will support the efforts of grantees "to ensure students get on, stay on, and complete post-secondary degrees and credentials leading to jobs and careers that promote upward economic mobility."
