H. Major research and public service activities

OCC is not required to submit to the National Science Foundation their R&D Expenditures form #411 as we do not receive any federal, state or local funding to specifically support R&D activities, nor are any institutional funds budgeted or expensed for this purpose.

Examples of OCC's public service activities include the following.

Community Medical Center utilization of Ocean County College Simulation

The Medical Residency Program at Community Medical Center, an RWJ Barnabas Health facility, utilizes the Simulation Center in the H. Hovnanian Health Sciences (HOVN) building for the third year. Medical Residents who have graduated from various medical programs complete simulation experiences and lectures in the HOVN building monthly, under the direction of Attending Physicians.

The Ocean County College Foundation

Originally established to provide scholarships to students attending Ocean County College, the Foundation has expanded its outreach to partner with community leaders in business, industry, education and government to reach a common goal to provide quality, affordable education to our students and to prepare them to assume their roles in our society.

The Foundation hosts, promotes, and sponsors events throughout the year that enrich our community and support our annual goals. The 2024 event season includes annual favorites, such as a schedule of diverse guest lecturers through the Blauvelt Speaker Series, a concert series, several sporting and wellness events, and our annual Summer Scholarship Celebration.

The Foundation distributed over \$1,000,000 in scholarship and programmatic support during FY2024 and since its inception, over \$20.5 million. This funding continues to provide for tuition, global and domestic travel experiences, capital projects, vocational certificate support, early college, jump start and academy education and much more.

It has addressed the needs of students via the Student Emergency Relief Fund (SERF) by providing financial assistance during emergencies so that students could remain in school. It facilitates critical programs, including the support of our on-campus Helping Hands Food Pantry, through a partnership with Fulfill, to help alleviate the food insecurity of our students and their families.

Tuition Waivers

Tuition waivers are available for the following populations; qualifying members of the New Jersey National Guard, their surviving spouses and children, eligible unemployed individuals, volunteer fire, first aid and rescue squad, their dependent children and spouses.



Adult Education, Civics & Workforce Preparation Program

The Adult Education, Civics, & Workforce Preparation Program (AECWP) is funded by the State of New Jersey Department of Labor and Workforce Development for Consolidated Adult Basic Skills (Title II) and Integrated English Literacy and Civics Education (IELCE) Programs.

Ocean County Achievement Center

The Ocean County Achievement Center is a collaborative partnership with Ocean County College, Ocean County PIC, Inc., Georgian Court University, and Goodwill's Helms Academy. The Ocean County Achievement Center is hosted on OCC's campus and provides free comprehensive and individualized services to out-of-school young adults and adults. The services will address academic, career, and financial goals. Services are provided by various community partners to engage young adults and adults in educational programs, integrated education training, career exploration, work readiness training, internships, on-the-job learning, leadership development, job placement, adult mentoring, and work experience opportunities.

Various funding sources provide young adults (16-24) and adults with comprehensive services to gain career-decision-making tools, and to prepare for their next steps in education and employment

Workforce Readiness Assistance Program

The Work Readiness Assistance Program is funded through a grant provided by the Ocean County Department of Human Services and the Ocean County Board of Commissioners.

Displaced Homemakers Program of Ocean County

This program is designed to provide services to individuals who have lost their primary source of income due to separation, divorce, disability or death of the primary family provider and to help them become economically self-sufficient. It is funded through a grant from the New Jersey Division on Women and services include career, employment and life counseling, connection to social and community organizations, and assistance with the job search.

Helping Hands Food Pantry

At Helping Hands, we provide Ocean County College and Kean Ocean students with non-academic support to help them succeed. In the food pantry, we offer snacks, drinks, and meals to students in need. Our office also provides resources for financial assistance, referrals for housing support, and more.

The Grunin Center

The Jay and Linda Grunin Center for the Arts provides a wide range of artistic programming and services (both entertainment and educational) to the college community, the broader community, and for many outside rental organizations. The department's expertise in programming and event management, marketing and sales, operations and production, education and community engagement help to ensure that the "Grunin Center is a vibrant and engaging cultural center that serves the needs of the community." The center holds special partnerships



with the OCC Repertory Theatre Company, the Grunin Performing Arts Academy (OCVTS performing arts high school) and BCCT (Brick Community Children's Theatre).

The mission of the Jay and Linda Grunin Center for the Arts is to provide transformative experiences that connect our community through the Arts and to serve as a cultural resource for the students of Ocean County College and the residents of the Jersey Shore.

Robert J Novins Planetarium

The mission of the Robert J. Novins Planetarium is to bring students, residents, and visitors to Ocean County together through immersive, engaging, and educational astronomy and science related programming. The staff offer weekly live sky and star talks, educational movies, laser shows, free astronomy events and activities, including live star watches with the ASTRA club. The planetarium also provides educational opportunities for OCC students, for K-12 schools, camps, scouts, special needs groups, and seniors, which may include hands-on learning activities in addition to dome shows.

The OCC Center for Holocaust, Genocide, and Human Rights Education

The Center fosters student and community understanding of the causes and legacy of the Holocaust and other genocides such as the Armenian genocide, to create an acute awareness of contemporary human rights abuses locally, nationally, and globally through lectures, exhibits, and events.

OCEAN TV-20

Ocean County College is proud to provide Ocean TV-20, a television channel dedicated to service the community with high-quality programming around the clock. Broadcasting 24 hours a day, 7 days a week, Ocean TV-20 brings a diverse range of local, national and international shows to viewers.

Our television studio is home to a variety of original programming including *Shore of Support*, a show that highlights organizations enhancing the lives of our community through charitable efforts.



I. Major capital projects

COMPLETED CAPITAL PROJECTS

Library Modernization

The Library Building #3 is a 3-story, 59,000 square foot building originally constructed in 1966, with a portion renovated in 1994. Ocean County College determined that the building requires modifications in its use and design due to changes in student library usage, study habits and technology requirements. As such, the goal to modernize the building was achieved by installing new flooring, lighting, wall coverings, paint, furniture, upgrading the IT/audio visual (AV) wiring and capabilities and installing new technological equipment throughout the Library.

Main Entrance Electronic Signage

The electronic signage located at the intersection of Hooper Avenue and College Drive, needed to be replaced. The existing signage is approximately 11 years old and must be upgraded to incorporate the latest technology available to accommodate the College's messaging needs. The new signage was raised up, 5' higher, to improve visibility to motorists and now utilizes a cloud based system that allows more user friendly options for programming messages

TV Studio Lighting Project

Ocean County College contracted with a consultant firm and general contractor to upgrade the lighting equipment in the on-campus TV Studio. The TV Studio now utilizes current technologies available in the tv/video production industry and offers students interactive technical and educational opportunities.

ON-GOING CAPITAL PROJECTS

Grunin Renovation of the Former Human Resource Offices to Music Rooms

The College has determined that new music practice rooms are required in the Grunin Center, Building 11. An ideal location is the former Human Resources department's office suite, that will be converted into music practice rooms for students. An architect was awarded the project who completed programming and design, and construction is anticipated to commence in fall 2024.

New Administration Building

Built in 1974, the existing Administration Building has had thousands of students and staff pass through its halls and rooms over the past 49 years of existence. Through the passage of time, the building has been through many repairs, especially on the first and ground floors.

A new state of the art Administration Building will be constructed next to the Planetarium to replace the existing building. It will incorporate an open floor plan and house multiple campus



departments, including the Office of the President. Architectural design is currently being performed and the anticipated construction commencement date is scheduled for spring 2025.

Grunin Center Lobby

Ocean County College has determined that the Grunin Center Building #11A requires an expanded lobby to hold full audiences for theater functions and provide an ADA compliant entrance to access the Grunin Building, closer to parking lot #2. This project will also address the current issue of cold air and strong winds infiltrating the main lobby when the double entrance doors are used during the winter season and inadequate cooling in the summer. The goal is to create a lobby that can be opened for public events with an ADA pathway that is always accessible for general use to access the main theater and campus mall via an elevator.

An architectural firm has been engaged and begun the design and programming phase of the project. Upon design completion, the College will issue bids to general contractors to perform the construction in fall of 2024.

Grunin Theater Lighting Project

Ocean County College has contracted with a consultant firm to upgrade the Grunin Theater' theatrical and house lighting. The modernization of equipment will provide enhanced engagement and education opportunities for campus populations, K-12 students, and the public, and will be energy efficient. The College's intent is to raise the level of the Theater's infrastructure to be consistent with what performers and artist's request in their contracts and riders, and provide a more enhanced experience for students and community patrons. Work will be scheduled to be performed when the Theater is closed for renovations in January – May 2025.

Parking Lot #1

The College has determined that upgrades must be made to Parking Lot #1 and other areas on campus. The Parking Lot #1 & 1R upgrades include pavement resurfacing, lot striping, new emergency call boxes and the addition of islands, curbs and speed bumps as necessary to control traffic and redirect pedestrians. Electric vehicle charging stations and will also be incorporated in the design for present and/or future use in Lot #1 along with a feasibility study for the utilization of solar panels. Other areas on campus that will be included are the striping of the loop road, upgrading emergency call boxes, and constructing a dedicated ADA parking lot in close proximity to the Gateway Building. Request for proposals will be sent out to A/E firms and once awarded, design and programming will begin. Construction to commence in summer 2025.
