Important Reminders:

9A:11-2.9 (d) - Each semester of part-time attendance for which an Article III part-time undergraduate grant is awarded shall count as one-half of a semester of grant eligibility. In no case shall a student receive such a grant for more than three semesters in pursuit of an associate degree or four semesters in pursuit of a baccalaureate degree.

9A:11-2.9 (e) - Institutions approved to award Article III part-time undergraduate grants shall not award such grants to more than 10 percent of their total EOF-funded population in any given semester.

9A:11-2.9 (f) - Renewal students enrolled in their last semester of study before graduation who can meet the requirements for their degree by registering as part-time students are eligible to receive a semester maximum full-time EOF academic year Article III grant award, as long as the student's financial aid award package consisting of the New Jersey Tuition Aid Grant (TAG), scholarships and other financial assistance does not exceed a student's cost of attendance. *(Note: This student should be coded with the admission type "Less than FT Graduating Senior" in NJFAMS.)*
