Serve 'Some College, No Degree' Students

In Fiscal Year 2023, the State launched an innovative partnership with ReUp and an initial cohort of NJ colleges and universities as part of the foundational work for the statewide 'Some College, No Degree' (SCND) initiative. Based on the success of the <u>initial year</u>, OSHE is continuing the statewide partnership with ReUp for Fiscal Year 2024 and is looking to identify six additional public institutions of higher education interested and ready to engage prospective some college, no degree students for targeted outreach and re-enrollment supports. State funding will be utilized to support this second cohort of institutions.

Eligible institutions for the FY2024 second cohort include NJ public two- and four-year institutions of higher education. Institutions already part of the first cohort from FY2023 do not need to reapply. Eligible institutions interested in participating must submit an application, inclusive of a letter of intent acknowledging their commitment to support the partnership and meet project timelines and requirements. Institutions should only submit one application per institution. The application was previously shared with eligible institutions on September 12, 2023 and a template is provided below (Word version available upon request). Final decisions for participation will be made based on considerations to ensure sector and geographic diversity.

In order to maximize enrollment results for spring, outreach efforts to former students will begin no later than November 7th, 2023. Application deadlines significantly impact stopped out earners' ability to consider reenrolling as they often have multiple competing life priorities that they need to sort out before applying. To maximize success, institutions with application deadlines close to the semester start date will be prioritized as part of the selection criteria, as this allows returning students ample time to prepare applications and overcome barriers.
