### To Increase Community Capacity of Provider Managed Housing for Individuals with Acute Behavioral and/or Medical Needs

- On June 22, 2023 DDD issued a Request for Proposals (RFP) titled <u>To Increase Community Capacity of Provider Managed Housing for</u> Individuals with Acute Behavioral and/or Medical Needs
- This RFP focuses on increasing community capacity and choice in housing options for individuals with IDDs who have acute behavioral and/or medical needs.
- Funding in the amount of \$5 million is available for initiative through the Money Follows the Person Demonstration Program.

### To Increase Community Capacity of Provider Managed Housing for Individuals with Acute Behavioral and/or Medical Needs

- Awardees will receive up to \$90,000 in capital funding to offset costs incurred in the acquisition, development and renovation of group homes that will serve newly placed individuals with acute behavioral and/or medical needs.
- The <u>Notice of Funding Availability</u>, <u>Request for Proposals</u>, and <u>Questions and Answers</u> are posted on the <u>DHS Public Notices</u> webpage.
- The Deadline for Proposals is May 1, 2024.

### Support for People Transitioning From Nursing Facilities

- On February 7, 2024 DDD released an RFP titled <u>To Support the Development of Homes for People with Intellectual and/or Developmental Disabilities Transitioning from Nursing Facilities and Other Qualified Institutions.</u>
- Successful bidders will develop new residential opportunities to support people to move from nursing facilities into community-based residential homes.
- Funds provided will be used to develop new sites or enhance existing sites to provide accessibility and other modifications that are needed to facilitate appropriate supports for a person who is moving from a nursing facility or other qualified institution.

### Support for People Transitioning From Nursing Facilities

- A total of \$6M in funding is available for the development of 100 new beds (\$60,000 per bed with no more than \$240,000 allocated to a single home).
- The Notice of Funding Availability and Request for Proposal are posted on the DHS Grants, RFPs, Public Notices webpage.
- The deadline to submit questions is February 22, 2024 and the deadline for proposal submissions is May 1, 2024

# Emergency Capacity Services Homes for Individuals with Intellectual and/or Developmental Disabilities (AWARDED)

- On August 30, 2023 the Division released an RFP titled <u>Emergency</u> <u>Capacity Services Homes for Individuals with Intellectual and/or</u> <u>Developmental Disabilities.</u>
- This RFP is released to re-procure the existing eight (8) four (4) person ECS programs to two or more qualified providers and support the development of enhanced behavioral services for each program.
- ECS programs support individuals with intellectual and developmental disabilities (IDD), including those with acute behavioral needs, who are in need of immediate residential/day support.

## **Emergency Capacity Services Homes for Individuals with Intellectual and/or Developmental Disabilities**

- The primary purpose of the ECS programs is to provide community residential/day supports for individuals with IDD who are in need of immediate residential/day services due to homelessness or other emergent circumstance.
- Contracts were awarded to the following agencies:
  - 4 programs to Community Options, Inc.;
  - 3 programs to Community Access Unlimited; and
  - 1 program to Oaks Integrated Care.
- The programs are to be operational by June 30, 2024.

#### **Choking Prevention Awareness**

- March 28, 2024 is National Choking Awareness Day.
- The Division has dedicated March 2024 to raising awareness about this important issue.
- During March, our DDD Resource Team is providing in-person workshops at local Community Service Office locations for agency staff and self-directed employees, and virtual webinars open to anyone. Advance registration is required.

- Annual NCI State of the Workforce Survey
  - Collects comprehensive data on the Direct Support Professional (DSP)
    workforce providing direct supports to adults with intellectual and
    developmental disabilities (IDD).
  - Resulting data helps state developmental disabilities systems examine workforce challenges, identify areas for further investigation, benchmark their workforce data, measure improvements made through policy or programmatic changes, and compare their state data to those of other states and the NCI-IDD average.
  - NOTE NCI does not offer an equivalent survey for Fiscal Intermediaries/Self-Directed Employee wages. The Division has expressed interest to NCI in piloting/participating in such a survey when available.

- NCI State of the Workforce Survey
  - The Division will send email invitations on or about March 1 with instructions to eligible provider agencies and a link to complete the online survey.
  - Invitations will be sent to provider agency email address on file in iRecord.
  - Survey will be open through June 30, 2024.
  - The Division strongly encourages all eligible provider agencies to complete the survey, as their participation is critical to ensuring valid results.

- 2023-2024 NCI In-Person, Adult Family, and Family/Guardian Surveys began in December 2023 – ongoing through June 30, 2024
  - All surveys are voluntary.
  - Seek to measure how well the public system assists adults with developmental disabilities, and their families, to exercise choice and control in their decision-making, participate in their communities, and maintain family relationships, as well as how satisfied families are with services and supports they receive, and how supports have affected their lives.
  - Cover key areas such as employment, respect/rights, service planning, community inclusion, choice, and health and safety.

- In-Person Survey face-to-face conversation with a minimum of 400 randomly chosen individuals 21 and older who are receiving at least one DDD service in addition to Support Coordination.
- Adult Family Survey online survey for family members who have an adult (21 or older) with IDD who lives in the family home and receives at least one DDD service in addition to Support Coordination.
- Family/Guardian Survey online survey for family members/guardians who have an adult (21 or older) with IDD who lives outside of the family home and receives at least one DDD service in addition to Support Coordination.
