Governor Christie Announces the Departure of Department of Human Services Commissioner Velez

On Tuesday, February 16, Governor Chris Christie announced that Department of Human Services' Commissioner Jennifer Velez is resigning at the end of the month. The following was in his press release: "Jen Velez has been one of the smartest and most dedicated people I have had the honor of knowing during my time as governor. She has been a tremendous advocate in our efforts to deliver effective, cost-efficient, and high quality services to the most vulnerable New Jerseyans, and has done so with a genuine fervor and compassion to help make people's lives better," said Governor Christie. "I thank Jen for her service and for the passion and effort she has poured into this job for nearly a decade and wish her well as she moves on to her next endeavor."

The longest serving department Commissioner, to date, Velez is leaving to become the Senior Vice President of Strategy and Planning for Barnabas Health in West Orange, NJ.

"Serving this department under the Governor's leadership has been one of the most gratifying and fulfilling roles I've ever had," said Velez. "I have worked alongside an incredibly talented team of subject-matter experts who really understand and are committed to positive reforms that improve the lives of some of New Jersey's most vulnerable residents. I'm grateful to have been a part of this Administration and to have enjoyed unwavering support from the Governor."

Elizabeth Connolly, the department's current Chief of Staff, will become acting commissioner. Connolly has worked in various roles at the department for 26 years. She holds a Bachelor of Arts degree and Masters in Public Administration from Seton Hall University and lives in North Brunswick.

Assistive Technology Demonstration Centers

One of the services offered by the DDHH is to operate assistive technology demonstration centers, where constituents are able to learn and gain hands on experience with equipment and devices that can enhance the quality of lives of people with hearing loss.

DDHH evaluates these sites in terms of frequency of use, ease of access and location to ensure that we are able to reach the maximum number of constituents. Of the five statewide centers, it has been decided to relocate two of them in order to better serve our constituents. One of the centers currently located at the New Jersey School for the Deaf, in West Trenton will be relocated to the new DDHH Offices at Quakerbridge Plaza, Hamilton. The other center, currently housed at Burlington County College, Mt Holly, will be relocated to a yet to be determined location in southern New Jersey.

DDHH wishes to express its appreciation to the New Jersey School for the Deaf and to Burlington County College for partnering with the division and permitting it to use their facilities to serve our constituents.

Deaf and Hard of Hearing Awareness Day

For the past 31 years, the DDHH in collaboration with its partners, New Jersey Association for the Deaf, NJAD, New Jersey Deaf Awareness Week, and New Jersey Relay Services have sponsored Deaf and Hard of Hearing Awareness Day at Six Flags. This event strives to provide awareness activities and resources to educate the thousands of visitors to the park about hearing loss.

DDHH also works with the park providing consultation on strategies to make the park's activities and show communication accessible for individuals and their families who are Deaf and hard of hearing. DDHH staff provides sensitively training about hearing loss to park employees. The training includes teaching basic sign language, which employees eagerly use when greeting people throughout the park. Sign language interpreters are available at many of the popular animal events, making the shows communication accessible.

This year, Deaf and hard of Hearing Awareness day is planned for Saturday June 6. The system was designed by the Department of Human Service's Information and Technology Office precisely for the DDHH programs and services it provides.

Many wish to donate old and/or no-longer-needed technology. Our consumers often ask where they can donate devices such as amplified phones and hearing aids. Although DDHH does not accept contributions, there are agencies that may accept them.

For devices such as telephones, alerting technology and other similar equipment, gently used pieces can become part of the Back in Action program, *http://backinaction.drnj.org/home.php* Back In Action is a "classified ads" feature that connects people with available assistive technology and is a project of the Assistive Technology Advocacy Center (ATAC), a program of Disability Rights New Jersey (DRNJ). DRNJ is a nonprofit corporation. This is a user-driven database with entry, edit, delete and search capabilities. Back In Action is primarily for residents of New Jersey, although entries from neighboring states are accepted. The program is designed to facilitate equipment exchange between individuals and is not for the use of vendors or distributors. DRNJ does not profit from the sale of listed devices. The Internet is the easiest way to access Back In Action listings. If you are unable to access the internet, or have specific problems in viewing the Back In Action listings, please contact ATAC for assistance at 1-800-922-7233 from within NJ, or call the main number at 609-292-9742.

If you have a used hearing aid and wish to donate it, we have the place. Used hearing aids will be reconditioned and dispensed to others in need in New Jersey. The New Jersey Hearing Aid Project initiative is a joint venture with the New Jersey Division of the Deaf and Hard of Hearing, Sertoma, Inc., and Montclair State University. The Project graciously accepts donations of ALL hearing aids regardless of function, style, or age of instrument. In February, the New Jersey Division of the Deaf and Hard of Hearing (DDHH) in collaboration with Carl Robinson, Public Affairs Specialist for the Social Security Administration, held a presentation for the deaf and hard of hearing community in Freehold, NJ. Approximately thirty deaf and hard of hearing people were in attendance.

Many deaf and hard of hearing individuals work while receiving Social Security benefits and Mr. Robinson's presentation focused on Social Security Work Incentives for both the Social Security Income (SSI) and Social Security Disability Income (SSDI) programs. Accommodations including American Sign Language Interpreters, Deaf-Blind Interpreters, CART, and Assistive Listening Devices were provided.

DDHH wants to note that the deaf and hard of hearing community has helped DDHH become increasingly aware of communication access issues at social security field offices in NJ. In response to the community's concerns, DDHH met with key Social Security representatives including Mr. Robinson to address these concerns. Carl Robinson and DDHH worked together to develop a phone contact list for each NJ Social Security field office so deaf and hard of hearing individuals can reach out to their local Social Security field office directly and make sign language interpreter requests. Deaf Advocacy Project

In March 2014, the Deaf Advocacy Project was initiated after two Deaf representatives of the Deaf and hard of hearing community, Annmarie Buraczeski and Michelle Cline, approached the NJ Coalition for Battered Women (NJCBW) to discuss the gap they saw in services for Deaf and hard of hearing survivors of domestic violence (DV) and sexual assault (SA).

To bridge the gap in services for Deaf and hard of hearing victims and survivors of DV and SA, a committee consisting of representatives from NJCBW, Woman Space (Mercer County), NJ Coalition Against Sexual Assault (NJCASA), and the NJ Division of the Deaf and Hard of Hearing (DDHH) was established. The committee developed project goals and objectives for improving access for victims and survivors. The major goals included regional trainings called "Getting to know Deaf people better"; recruiting potential DV& SA advocates that are fluent in American Sign Language; and train the advocates on how to become more effective.

DDHH helped support this project by providing communication access sponsorship for regional trainings that took place in Hamilton, Voorhees, and the upcoming March training in Morristown and for committee meetings.

Michelle and Annmarie developed plans to recruit potential advocates for Deaf and hard of hearing victims and survivors. To obtain victim counselor privilege in New Jersey, the state law requires 40 hours of DV and SA training. Advocates will be expected to take the trainings through Woman Space's DV and SA Response Team training program. The committee is also working on bringing in 18 hours of specialized training provided by a Deaf DV and SA expert.

The committee has requested financial support from the Office of Victims of Crime Training and Technical Assistance Center to fund this training.
