# Dear CapTel Equipment Provider, From WCI, Captel

We're excited to inform you about a new CapTel® product – the CapTel 880iB – designed for people who are Deaf-Blind. The new CapTel 880iB, also referred to as "Braille CapTel", allows people with both vision and hearing loss to read Braille captions during their telephone conversations.

With Braille CapTel, the user connects their Braille display reader (sold separately by other vendors) to the CapTel 880iB via Bluetooth or with a USB cable. During their calls, the CapTel 880iB displays captions of everything the caller says on the Braille display for the user to read in Braille.

The ideal candidate for this equipment is a person who has both vision and hearing loss, who reads Braille, and who speaks for him- or herself.

We're happy to work with you if your program is interested in providing CapTel 880iB to serve people with both vision and hearing loss. Staff training will be provided through webcasts, training videos, or via videophone.

CapTel 880iB is also available through iCanConnect/the National Deaf Blind Equipment Distribution Program (NDBEDP), which provides one-on-one user training and installation support.

PLEASE NOTE: Because CapTel 880iB is not a subsidized product, customers are not able to get a free CapTel 880iB using the third-party certification process that covers other CapTel models. Deaf-Blind individuals need to acquire a CapTel 880iB either through a state Equipment Distribution Program, through programs such as iCanConnect, or through local Deaf-Blind support agencies.

Because of the highly specialized nature of this equipment and the limited user base, the CapTel 880iB must be ordered on an as-needed basis. Programs may not stock this equipment and demo models are not available.
