## DDHH Communication Access Service

*New Jersey Division of the Deaf and Hard of Hearing (DDHH)* operates a communication access services program. A large portion of this program focuses on advocacy. Individuals who have been denied access to doctors' offices or other entity, often contact DDHH for assistance. DDHH works in collaboration with the client to advocate for communication access services and to educate the entity of their legal responsibilities under the *Americans with Disabilities Act* and the *New Jersey Law Against Discrimination*. As a result of DDHH intervention, many consumers obtain the sign language interpreters or realtime captioning services they require. The following data table shows the number of request for referral services and the percentage of requests filled From July 1, 2015 – December 31, 2015.

Communication Access Services	
Requests for sign language services	156
Sign language requests filled	98 %
Requests for captioning services	12
Captioning requests filled	92 %

# Directory of Sign Language Interpreter Lists Updated

DDHH Director David Alexander disseminated a letter to interpreters on the division's directory of sign language interpreter lists advising that, going forward, only those who have Registry of Interpreters (RID) for the Deaf certification will be eligible to remain on the list. This policy impacts interpreters who were DDHH screened in the past, but never received the RID credential which is recognized throughout the country. ## Social Security Disability and Work - What's New in 2016?

You can create your own Social Security account at [www.socialsecurity.gov/myaccount](http://www.socialsecurity.gov/myaccount) which enables you to:

- Request a replacement Social Security card if you meet certain requirements
- Get your Social Security Statement to review
- Obtain estimates of your future retirement, disability, and survivors benefits
- View your earnings once a year to verify the amounts posted are correct; and
- See the estimated Social Security and Medicare taxes you've paid.

## Disaster Declaration Issued for Parts of New Jersey

The federal government has approved Governor Chris Christie's request for a disaster declaration to help parts of New Jersey recover costs stemming from the blizzard that dumped nearly three feet of snow in January. Federal funding is available to state and local governments and certain private nonprofit organizations on a cost-sharing basis for emergency work and the repair or replacement of facilities damaged in several counties.
