## NJ Law Against Discrimination Seminar

The Division of the Deaf and Hard of Hearing and the Office of the Attorney General, Division on Civil Rights held the first of four scheduled public seminars on September 27th at Stockton University to create awareness for the NJ Law Against Discrimination and the types of discrimination that the Deaf and Hard of Hearing community faces. Panel representatives, Philip Freeman, Assistant Director and Edward Haas, Legal Specialist, from the Division on Civil Rights, Trevor Melton, Education Specialist, from the New Jersey Department of Education, and David Alexander, Director, from the Division of the Deaf and Hard of Hearing spoke with audience members on accommodation/communication access issues in K-12 education, places of public accommodations, medical care facilities, employment, etc.

## Text 911



On Wednesday, September 7, DDHH Director David Alexander (*shown at podium*) and other state representatives announced the new statewide *Text 911* accessibility during a press conference at Rutgers State University. The DDHH will continue to work cooperatively with law enforcement personnel regarding interacting with the Deaf and hard of hearing population in New Jersey. The New Jersey Office of Information Technology offered the following public guidelines:

## How to text 911

- Open the message app on your phone or wireless device
- In the “To” field, type “911” with no punctuation
- In the message field, type the location (address and municipality) and a brief description of the problem (example: “1234 E Main Street Franklin Twp someone breaking in”).

## When should you text 911

- If you have a speech or hearing impairment.
- If speaking may cause you harm, like in a break-in or domestic violence situation.
- Be sure to silence your phone so that the sound of a 911 reply does not give your hiding location away.

## Induction Loop Resources

Background noise makes listening very difficult for people with hearing aids or cochlear implants. Audio loops, also called induction loops, can minimize the effect of background noise and help people hear more clearly as long as their hearing instruments are equipped with Telecoils (T-Coils). An audio loop is a wire that circles a room and is connected to a sound or PA system. The loop transmits the sound electromagnetically and the signal is then picked up by the telecoil in the hearing aid or cochlear implant. Induction Loops can be installed in such places as churches, theaters, doctors’ offices, pharmacies, township halls, bank teller windows, restaurants, libraries, schools, hotels, convention centers and hospitals et. al.
