FINAL DECISION

Petitioner appeals from the Respondent Agency's termination of Emergency Assistance ("EA") benefits. The Agency terminated Petitioner's EA benefits contending that she had exhausted her lifetime limit of EA benefits, plus all available extensions. Because Petitioner appealed, the matter was transmitted to the Office of Administrative Law for a hearing. A hearing was initially scheduled for November 8, 2017, but was adjourned with the consent of both parties. On November 27, 2017, the Honorable Julio C. Morejon, Administrative Law Judge ("ALJ"), held a plenary hearing, took testimony, and admitted documents. On December 29, 2017, the ALJ issued an Initial Decision, reversing the Agency's determination.

Exceptions to the Initial Decision were filed by the Agency on January 10, 2018.

As the Director of the Division of Family Development, Department of Human Services, I have reviewed the ALJ's Initial Decision and the record, and I hereby REJECT the ALJ's Initial Decision, and AFFIRM the Agency's determination.

Under the Work First New Jersey ("WFNJ") regulations, EA benefits are limited to 12 cumulative months during the lifetime of a case, plus limited extensions. See N.J.A.C. 10:90-6.4(a) and -6.4(b). A WFNJ/Temporary Assistance for Needy Families ("TANF") recipient may qualify for up to two six-month extensions of EA benefits when an "extreme hardship" exists pursuant to the criteria set forth in N.J.A.C. 10:90-6.4(b)(1). See N.J.A.C. 10:90-6.4(d). Thus, the maximum amount of EA benefits that a WFNJ/TANF benefits recipient may receive is 24 months.

Here, the record indicates that Petitioner is a WFNJ/TANF benefits recipient, who had received 25 months of EA benefits, as of September 2017. See Initial Decision at 2; see also Exhibit R-3. Based on the foregoing, I find that Petitioner has exhausted her lifetime limit of EA benefits, plus all available extensions and that there currently exists no regulatory authority by which the Agency may grant Petitioner additional EA benefits. See N.J.A.C. 10:90-6.4(a), (b), (d). Therefore, I find that the Agency's termination of Petitioner's EA benefits was proper and must stand. See Exhibit R-1.

Accordingly, the Initial Decision is hereby REJECTED, and the Agency's action is AFFIRMED.
