DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS MARCH 2024

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of March, the TANF caseload had increased by 709 cases, from 11,153 in March 2023 to 11,862 in March 2024; an increase of 6.4%.
- The counties with caseloads that increased the most since March 2023 were Morris (24.8%), Essex (21.7%), and Somerset (20.2%).
- The counties with caseloads that decreased the most since March 2023 were Hunterdon (-20.8%), Sussex (-20.6%), and Warren (-17.4%).
- Of the WFNJ/TANF cases, 2,453 or 20.7% were child-only in March 2024.
- The counties with the most child-only cases were Camden (416), Hudson (336), and Essex (265).
- Hudson (5,199), Essex (4,961), and Camden (4,325) counties had the greatest number of persons receiving TANF in March 2024.

NJ SNAP (Formerly FOOD STAMPS)

- In March 2024, there were 439,046 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 19,105 or 4.5%, since March 2023.
- There were 834,476 persons receiving NJ SNAP benefits as of March 2024; an increase of 732 or 0.1% since March 2023.
- The counties having the highest SNAP caseload increase since March 2023 were Union (23.3%), Hudson (10.4%), and Morris (9%).
- The counties having the highest SNAP caseload decrease since March 2023 were Atlantic (-5.4%), Sussex (-1.4%), and Cape May (-0.2%).

EMERGENCY ASSISTANCE

- There were 1,685 TANF families receiving Emergency Assistance (EA) in March 2024; an increase of 223 or 15.3% since March 2023.
- In March 2024, EA payments were made for 582 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS MARCH 2024

- There were 2,078 GA cases with Emergency Assistance payments in March 2024; an increase of 241 or 10% since March 2023.
- The counties that showed the highest percent increase in Emergency Assistance payments were Passaic (165%), Gloucester (164.7%), and Sussex (150%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Hunterdon (-51.5%), Essex (-24.7%), and Middlesex (-18.5%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 10,162 to 14,503 since March 2023; an increase of 42.7%.
- There were 10,510 Employable GA and 3,993 Unemployable GA cases in March 2024.
- The counties that showed a percent increase for GA cases were Passaic (97.1%), Hudson (78%), and Essex (62.6%) since March 2023.
- The counties that showed the highest percent decrease for GA cases since March 2023 were Hunterdon (-21.1%) and Sussex (-1.7%).
- In March 2024, GA cases showed a 3.99% increase since February 2024.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$264 million from January 2024 to March 2024; a decrease of -3.38% over the same period from FFY 2023.
- Total distributions decreased -3.4% from March 2023.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of March 2024, there were 546 families in which at least one member was employed and an additional 181 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (127), Hudson (88), and Mercer (53).
- There were 260 former TANF cases receiving post-TANF support in the form of child care assistance.

NJ STATEWIDE Eligible Families Receiving WFNJ/TANF MARCH 2022 THROUGH MARCH 2024








Work Participation Rates Achieved Over 12 Month Period Ending with MARCH 2024









ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996. PRWORA established Temporary Assistance for Needy Families (TANF) as the replacement for AFDC cash assistance. WFNJ includes two segments, WFNJ/TANF for families with children, and WFNJ/GA (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
