### DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS AUGUST 2016

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

### WFNJ/TANF

- As of the end of August, the TANF caseload had decreased by 6,448 cases, from 27,185 in August 2015 to 20,737 in August 2016, a decrease of 23.7%.
- The county where the family caseload percentage increased since August 2015 was Warren (4.8%).
- The counties with caseloads that decreased the most since August 2015 were Ocean (-34.6%), Hunterdon (-37.7%) and Sussex (-44.4%).
- Of the WFNJ/TANF cases, 5,931 or 28.6% were child-only in August 2016.
- The counties with the most child-only cases were Essex (899), Camden (790) and Hudson (615).
- Essex (9,511), Passaic (6,692), Hudson (6,010), Camden (5,830) and Atlantic (3,572) counties had the greatest number of persons receiving TANF in August 2016.

### **NJ SNAP (formerly FOOD STAMPS)**

- In August 2016, there were 425,054 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 20,566 or 4.6%, since August 2015.
- There were 848,215 persons receiving NJ SNAP benefits as of August 2016, a decrease of 37,613 or 4.2% since August 2015.
- The three counties having the highest caseload decrease since August 2015 are Gloucester (9.8%), Burlington (11.0%) and Salem (11.3%).

### **EMERGENCY ASSISTANCE**

- There were 2,833 families receiving Emergency Assistance (EA) in August 2016, a decrease of 1,847 or 39.5% since August 2015.
- In August 2016, EA payments were made for 618 SSI recipients.

### **GENERAL ASSISTANCE**

### **GA Emergency Assistance**

- There were 2,862 Emergency Assistance payments made to GA cases in August 2016, a decrease of 1,231 or 30.1% since August 2015.
- The counties that showed the highest percent decrease in emergency assistance payments were Passaic (49.5%), Monmouth (50.7%) and Cumberland (66.7%).

### **GA Program**

- The total numbers of cases receiving GA has decreased from 24,130 to 17,338 since August 2015, a decrease of 28.1%.
- There were 7,978 Employable GA and 9,360 Unemployable GA cases in August 2016.
- The counties that showed the highest percent decrease for GA cases since August 2015 were Warren (39.4%), Cape May (43.8%) and Passaic (46.7%).
- In August 2016, GA cases showed a 0.6 percent decrease since July 2016.

### **CHILD SUPPORT SERVICES (Quarterly Report)**

- The total collection for the Child Support Services Program was about \$337 million from April 2016 to June 2016, an increase of 0.1 percent over the same period for FFY 2015.
- Total distributions decreased 2.2% from June 2015.


### **WORK FIRST NEW JERSEY (WFNJ)**

- During the report month of August 2016, there were 2,258 families in which at least one member was employed and an additional 384 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (494), Camden (270) and Passaic (265).
- There were 2,889 former TANF cases receiving post-TANF support in the form of child care assistance.





### **ACRONYMS**

**CASS**: Consolidated Assistance and Support System

**EMERGENCY ASSISTANCE (EA)** - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

**NJ SNAP** - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

**FAMIS**: Family Assistance Management Information System

**GAAS**: General Assistance Automated System

**NJKiDS**: New Jersey Kids Deserve Support (Child Support Information Management System)

**NJ MMIS SHARED DATA WAREHOUSE**: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

**OMEGA**: Online Management of Economic Goal Achievement

**SSI-EA**: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996. PRWORA established Temporary Assistance for Needy Families (TANF) as the replacement for AFDC cash assistance. WFNJ includes two segments, WFNJ/TANF for families with children, and WFNJ/GA (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
