FINAL DECISION

OAL DKT. NO. HPW 05517-19 S.H.

AGENCY DKT. NO. C102581015 (OCEAN COUNTY BOARD OF SOC. SVCS.)

Petitioner Agency charges Respondents, M.H. and S.H., with committing an intentional program violation ("IPV") of the Supplemental Nutrition Assistance Program ("SNAP"). The Agency asserts that Respondents failed to accurately report household earned income while they were receiving SNAP benefits, thereby causing them to receive an overissuance of benefits to which they were not entitled. On March 18, 2019, Respondent M.H. was properly noticed of the Administrative Disqualification Hearing, the charges against Respondents, and the proposed disqualification penalty via certified mail, return receipt requested. See Exhibit P-1 at 1-3. On April 4, 2019, Respondent S.H. was properly noticed of the Administrative Disqualification Hearing, the charges against Respondents, and the proposed disqualification penalty via personal service. Id. at 4-6. Because Respondents failed to execute and return the waiver of their right to a hearing, the matter was transmitted to the Office of Administrative Law for a hearing as a contested case. Id. at 3, 6. On May 14, 2019, the Honorable Edward J. Delanoy, Administrative Law Judge ("ALJ"), held a hearing, took testimony and admitted documents. Respondents did not appear for the hearing, and the matter proceeded ex parte, which is permissible pursuant to our regulatory scheme. See N.J.A.C. 1:10-14.1(d). The ALJ ordered the consolidation of the two separate cases, and the record then closed at the conclusion of the hearing. Respondents were permitted ten days following the hearing to present good cause for their failure to appear. Respondents provided no explanation or response.

On May 30, 2019, the ALJ issued an Initial Decision, which found that the Agency had met its burden in establishing, by clear and convincing evidence, that Respondents had deliberately and intentionally withheld information from the Agency, which resulted in Respondents receiving an overissuance of SNAP benefits to which they were not entitled. See Initial Decision at 5. Specifically, Respondents intentionally did not accurately report that S.H. had earned income during the period of September 2016, through October 2016, which resulted in an overissuance of SNAP benefits to Respondents in the amount of \$509. Id. at 4; see also Exhibits P-2 at 1, P-5, and N.J.A.C. 10:87-2.2(a), -5.2(a)(1), -5.4(a)(1), and -9.5.



As this was the first IPV committed by Respondents, the ALJ ordered the mandatory regulatory penalty of a 12-month disqualification from receipt of SNAP benefits, pursuant to N.J.A.C. 10:87-11.2(a)(1). See Initial Decision at 5.

No Exceptions to the Initial Decision were filed.

As the Director of the Division of Family Development, Department of Human Services, I have considered the Initial Decision in this matter, and following and independent evaluation of the record, I concur with the ALJ's decision and hereby adopt the Findings of Fact and Conclusion of Law in this matter.

I direct that the Agency proceed to recoup the overissuance.

Accordingly, based upon the foregoing, I hereby ADOPT the Initial Decision in this matter, and ORDER that the Respondents are disqualified from receipt of SNAP benefits for a period of 12 months. I further ORDER that the Agency is to recoup the overissuance.
