DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JANUARY 2024

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of January, the TANF caseload had increased by 780 cases, from 11,020 in January 2023 to 11,800 in January 2024; an increase of 7.1%.
- The counties with caseloads that increased the most since January 2023 were Essex (26%), Hudson (18.3%), and Burlington (12.8%).
- The counties with caseloads that decreased the most since January 2023 were Hunterdon (-20.8%), Sussex (-18.2%), and Passaic (-13.2%).
- Of the WFNJ/TANF cases, 2,456 or 20.8% were child-only in January 2024.
- The counties with the most child-only cases were Camden (421), Hudson (335), and Essex (261).
- Hudson (5,297), Essex (5,000), and Camden (4,218) counties had the greatest number of persons receiving TANF in January 2024.

NJ SNAP (Formerly FOOD STAMPS)

- In January 2024, there were 425,531 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 26,099 or 6.5%, since January 2023.
- There were 810,764 persons receiving NJ SNAP benefits as of January 2024; an increase of 36,182 or 4.7% since January 2023.
- The counties having the highest SNAP caseload increase since January 2023 were Union (30.4%), Hudson (14.2%), and Burlington (13.3%).
- The counties having the highest SNAP caseload decrease since January 2023 were Atlantic (- 5.7%), Cape May (-0.8%), and Essex (-0.5%).

EMERGENCY ASSISTANCE

- There were 1,506 TANF families receiving Emergency Assistance (EA) in January 2024; an increase of 256 or 20.5% since January 2023.
- In January 2024, EA payments were made for 576 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS JANUARY 2024

- There were 1,859 GA cases with Emergency Assistance payments in January 2024; an increase of 157 or 9.2% since January 2023.
- The counties that showed the highest percent increase in Emergency Assistance payments were Cape May (158.6%), Cumberland (107.7%), and Atlantic (93.9%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Salem (-75%), Hunterdon (-46.7%), and Middlesex (-38%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 10,207 to 13,830 since January 2023; an increase of 35.5%.
- There were 9,888 Employable GA and 3,942 Unemployable GA cases in January 2024.
- The counties that showed a percent increase for GA cases were Passaic (70%), Monmouth (59.6%), and Somerset (58.6%) since January 2023.
- The counties that showed the highest percent decrease for GA cases since January 2023 was Hunterdon (-27.3%).
- In January 2024, GA cases showed a 1.56% increase since December 2023.

CHILD SUPPORT SERVICES (QUARTERLY REPORT)

- The total collection for the Child Support Services Program was about \$256 million from October 2023 to December 2023; a decrease of -0.5% over the same period from FFY 2023.
- Total distributions decreased -0.7% from December 2022.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of January 2024, there were 589 families in which at least one member was employed and an additional 176 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (155), Hudson (120), and Mercer (59).
- There were 251 former TANF cases receiving post-TANF support in the form of child care assistance.

ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as NJ SNAP (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
