FINAL AGENCY DECISION

OAL DKT. NO. HMA 01653-25

(ON REMAND HMA 07117-24)

As Assistant Commissioner for the Division of Medical Assistance and Health Services, I have reviewed the record in this case, including the Initial Decision and the Office of Administrative Law (OAL) case file. Exceptions were not filed by either party in this matter. Procedurally, the time period for the Agency Head to render a Final Agency Decision is September 29, 2025, in accordance with N.J.S.A. 52:14B-10 which requires an Agency Head to adopt, reject, or modify the Initial Decision within 45 days of the agency's receipt.

An Initial Decision finding for Petitioner¹ was issued on October 18, 2024. As the decision failed to have the exhibits attached to it, the matter was remanded back to the

OAL. The matter was reviewed and the record was closed on August 12, 2025. ID at 2. A second Initial Decision was issued on August 14, 2025.

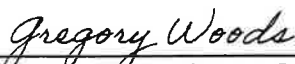
This matter arises from G.T. appealing the discharge/transfer notice issued by Mount Holly Rehab & Healthcare Center. Upon reviewing the documents contained in the OAL file, it was discovered that while the Appendix to the Initial Decision provides that the following exhibits were marked into evidence at the hearing in this matter: P-1 Incidence Reports; P-2 Behavioral Notes; P-3 Staff Complaints Against Respondent; P-4 Proof of Documents to Respondent; P-5 Alternate Placements ("Exhibit 2"); and R-1 Respondent Notes, only three of the referenced six exhibits were included in the OAL case file. While none of the exhibits were labeled, it appears that P-1 Incidence Reports; P-2 Behavioral Notes and P-3 Staff Complaints Against Respondent are in the file, but P-4 Proof of Documents to Respondent; P-5 Alternate Placements ("Exhibit 2"); and R-1 Respondent Notes are not in the file. In order to settle the record, I am remanding the matter to OAL for the purpose of producing the referenced exhibits for inclusion in the OAL case file. See N.J.A.C. 1:1-18.1 and N.J.Ct.R. 2:5-5(B).

Upon production of the missing exhibits, the matter, with the complete case file, should be returned to the agency to render a Final Agency Decision.

THEREFORE, it is on this 29th day of SEPTEMBER 2025,

ORDERED:

That the Initial Decision is hereby REMANDED, solely to settle the record and provide the missing exhibits that were entered into evidence below for the inclusion in the OAL case record.
