 - Q: Are their trauma services at CarePlus going to include adults?
 A: Current funding is bound to youth. As an agency CarePlus is trauma informed, and their programs are for adults and kids.
 - Q: SUD Treatment is difficult to do without brining up moments and words that retraumatize consumers, does CarePlus deal with that?A: Yes, it is a concern. The idea is to lower consumers stress response but not exacerbate trauma, the use of EMDR is helpful.

 - 1. DoE Mental Health Guide is still being vetted by Governor's Office, and it should be released in about two weeks.
 - 2. The Plan around the launch of the Guide is growing and being more robust.

 - 2. Discussion of Staffing Shortages: Limited pool of new staff and exodus of staff out of social service fields.

Dave offered to support a new Certificate of Need (CN) on this issue. Darlema asks him to join the Advocacy Committee. David Moore strongly advocates for a new CN.
