### **II. DMHAS Site Visit July 10-13, 2024 Update (Donna Migliorino DMHAS)**

- A. A report from SAMSHA won't be available for a couple of months
- B. The first two days were spent on site with DMHAS and CSOC. Information was sent to SAMHSA in advance of the site visit and some of the information that was presented during the visit was sent afterwards as additional information such as data dashboards.
- C. Additionally, there was a Consumer and Family Involvement meeting and a meeting with representatives from the Behavioral Health Planning Council.
- D. On the third day of the site visit, it was a day to visit programs – a 988 Call Center and a Coordinated Specialty Care-Community Integration program. Visit to sites included a program funded by the ESMI set aside and a Crisis Call Center.

- B. Children’s Systems of Care (Stacy Reh): No update provided
  - 1. Zero Suicide
    - a. A transformational framework for health and behavioral health care systems from the Zero Suicide Institute (ZSI) at the Educational Development Center
    - b. ZSI provides expertise, customized consultation, and training, to present an aspirational challenge to transform systems toward safer suicide care.
    - c. A two-year investment, implemented first with Care Management Organizations, Family Support Organizations, and some Out-of-Home (OOH) treatment providers, and, in year two, with Mobile Response Stabilization Services and additional OOH treatment providers.
    - d. Results: our partners have created and updated policies and protocols regarding suicide prevention and attempts; some have engaged in agency-wide staff training, policy consultation, workforce readiness surveys, and piloted screening projects that regularly assess a youth’s potential for suicidal thoughts or ideations, and, if identified, guide the youth onto a pathway that will build their resilience and coping skills, reducing risk, and helping them to thrive.
