- 1. The full Council membership was given wide opportunity to voice their thoughts about gaps in services through the survey that was distributed to all voting members. The results of that survey (15 responses & emails) were reviewed by the full BHPC Block Grant Committee, and the subsequent drafts were then revised further by the Chair of the BG Committee (Barb J), the Chair of the Council, the Vice Chair of the Council (with feedback the State Mental Health Planner. That final draft was given to the BG Committee and given several days to provide feedback. The document shared with the Council via email on 8/12/25 will be included in the 2026-2027 Block Grant Application
