I. Administrative Issues/Correspondence (Heather Simms)

II. DMHAS Request for Proposals (RFP) Process (Dave Helfand, DMHAS)

- A. Dave Helfand, DMHAS administrator with 25+ years of experience
- B. Overview of the RFP Process
 - 1. RFPs are posted on DMHAS website, providers must monitor that website.
 - a. Advice is to look on a weekly basis.
 - 2. Steps
 - 3. Families, peers, consumers and DMHAS staff review RFPs

- 4. There is an appeal process (ORPA requests are necessary to receive documents).
- 5. If an organization is given a preliminary award then a negotiation meeting between DMHAS and the presumptive awardee is held. Small sensible adjustments are discussed.
- 6. Monitoring for awardees via QCMR, looking at data of agencies whom have also received support.
- 7. DMHAS meets with providers to discuss service utilization and quality of programming.

C. Q&A

1. Q: How do you make sure that client outcomes are being achieved (Joe G.)?

A: Good and tough questions. Some programs (i.e., PACT) have EBPs, and some programs have more quantifiable measures. MK: DMHAS does systematically collect consumer data on social connectedness (as well as in other domains) via the DMHAS Annual Consumer Perception of Care Survey. Those results are shared in the aggregate with the BHPC.

Comment (HS): DMHAS Program Analysts and the Ombudsman are good resources.

- Q: How can caregivers and consumers become a part of the RFP and program reviews. A: There are options for members of the public to take part in the process. There are stringent conflict of interest and ethics guidelines that must be adhered to. Years ago consumers and families took part in licensing reviews, but that was years ago.
 Morgan Thompson: "Many contracts are also reviewed by local mental health boards and LACADAs which are always seeking people with lived experience to sit on those committees.
- 3. Q: Who is the Ombudsman?

A: Suzanne Mills is the DMHAS Ombudsman and DMHAS took effort to promote her presence. Elena Kravitz: Verified that Suzanne Mills is active and engaged in the community.

- I. Q: How is recovery defined? A: People define recovery for themselves. The concept of "recovery capital" may be very helpful.
- IV. **State Medicaid Office** (DMAHS): **Behavioral Health Integration** (Shanique McGowan, Irina Stuchinsky, NJ DMAHS)

- **IV. System Partner Updates** (Heather Simms)

Going forward all system partners are requested to provide the Council with brief, written updates by the Friday prior to the next BHPC meeting. Those updates will be provided to the Council prior to the meeting; this will give Council members an opportunity to pose questions to the system partners in a timely manner.

- A. Division of Mental Health and Addiction Services (Donna Migliorino, DMHAS).
 - 1. Donna discussed the following press release regarding NJ's PRWORA Actions in response to recent inquiries from the BHPC.
 - a. Starting on July 10, the U.S. Departments of Health and Human Services (HHS), Education (ED), Labor (DOL), and Justice (DOJ) issued a coordinated set of rules that suddenly reinterpret the

Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA).

- b. The agencies' new interpretation restricts states from using federal funds to provide services to individuals who cannot verify immigration status which is a major shift from decades-long federal practice. The rules took effect immediately, with minimal notice and affect not only undocumented immigrants, but also some lawful visa holders and, in practice, even U.S. citizens who lack access to formal documentation.
- c. Programs that are impacted in NJ include community mental health clinics and substance-abuse prevention and treatment programs; programs that help kids, including Head Start, career and technical education funding for students, and youth job development programs; and community organizations that serve those in crisis such as domestic violence intervention programs and soup kitchens.
- d. Joining NJ in filing this lawsuit, was New York, Washington, Rhode Island, Arizona, California, Colorado, Connecticut, Hawaii, Illinois, Maine, Maryland, Massachusetts, Michigan, Minnesota, Nevada, New Mexico, Oregon, Vermont, Wisconsin, and the District of Columbia.

- f. [Addendum: On the afternoon of 9/10/25 DMHAS was notified by the New Jersey's Attorney General's Office that the court has ruled in the PRWORA litigation.

The decision enjoined enforcement and implementation of the USDOJ, US HHS, USED and USDOL PRWORA notices in the plaintiff states, including New Jersey. Therefore, the stay that had been in place through today essentially continues, and we do not need to comply with the PRWORA notices until further order of the court.]

2. Donna responded to recent inquiries from the BHPC regarding the 2025 MHBG supplemental grant notice based upon the following Executive Order: Ending Crime and Disorder on America's Streets – The White House.

- a. Application for the \$557,055 was made and notification was received that are application was approved but no formal notice of award (NOA) was received as of yet.
- b. Once NJ receives the NOA, it will be reviewed at all levels to look at what the terms are of the grant and make a determination about accepting the award.
- c. The grant cannot be used for housing, but rather outreach to local housing authorities. The grant would also be used for outreach to homeless shelters, enhancing coordination with IOC providers, screening, emergency rooms, law enforcement, etc.
- B. Children's Systems of Care (Stacy Reh, DCF CSOC). No update was provided.
- C. Division of Developmental Disabilities (Jonathan Sabin)
 - 1. On August 6, DDD issued an updated Request for Proposals titled To Support the Development of Homes for People with Intellectual and/or Developmental Disabilities Transitioning from Nursing Facilities and other Qualified Institutions. The purpose of this RFP is to develop residential opportunities to support people in moving from nursing facilities into community-based residential homes. Funds will be able to be used for new sites or to enhance existing locations to provide accessibility and other modifications. For more information see the NOFA Updated SNF NOFA 3rd Release.pdf. Deadline to submit proposals is 4pm on October 1, 2025.
 - 2. The transition of the Division of Developmental Disabilities' (DDD) Vendor Fiscal/Employer Agent (VF/EA) Self-Direction Model to Acumen Fiscal Agent (Acumen), is continuing. All individuals currently receiving services paid through the former agency Public Partnerships Limited have been assigned to Acumen Cohorts (groups), which are being transitioned on a staggered schedule. B. Announcements:

- 1. SAMHSA \$19M Housing Capacity Funding (August 27, 2025)
 SAMHSA announced \$19 million in supplemental block grant funding to expand housing supports for people experiencing homelessness and serious mental illness (SMI). The funds emphasize cross-system partnerships between mental health, housing, and justice systems. A key component includes support for Assisted Outpatient Treatment (AOT), raising concern among advocates about conflicts with Housing First an evidence-based practice emphasizing voluntary supports. Opportunity for NJ: Consider how these dollars could be leveraged for peer-led housing supports, wellness respites, and voluntary services rather than coercive approaches. Key Question: Is New Jersey applying for or expecting to receive any of these funds? If so, how will they be allocated and implemented?
- 2. DHS/FEMA Restrictions on Aid to Undocumented Immigrants (Washington Post, Aug. 2025) DHS issued new rules requiring federally funded disaster aid groups to exclude undocumented immigrants and cooperate with immigration enforcement. This affects major organizations (e.g., Red Cross, Salvation Army) that have historically served all individuals regardless of immigration status. Experts warn this may undermine disaster relief efforts, create barriers for vulnerable populations, and raise ethical and constitutional concerns. For NJ: With a diverse population and frequent climate emergencies, this policy could impact equitable disaster recovery, especially for marginalized communities. Key Question: How might this affect behavioral health and housing supports in NJ during emergencies? What contingency planning exists to ensure no one is left behind?

Both issues highlight the importance of equity, access, and rights-based approaches. The Council may consider advocating for peer-informed, non-coercive solutions in response
