Dear Addictions Provider/Advocate:

The next Division of Mental Health and Addiction Services (DMHAS) general quarterly addictions provider meeting will be held on **May 24, 2012 at 10:00 a.m.** at **1200 Negron Drive in Hamilton (Hamilton Technology Center Auditorium)** off of Route 130 across from the Hamilton Marketplace. Please note that food and drink are **NOT** permitted in the auditorium. However, there are vending machines outside the auditorium from which to purchase refreshments during the break. A draft agenda is enclosed, as are directions to the auditorium. Note that there will be a guard when you enter through the doors and you may be required to show identification. This agenda focuses on agency readiness to implement fee-for-service.

Only individuals who will be directly updating the CRIS and require CRIS training need to attend; therefore agencies can send different individuals to the quarterly provider meeting and the CRIS training. FROM THE NEW JERSEY TURNPIKE:

- Take Exit 7A, and proceed west on I-195.
- Take Exit 5A (RT 130 south) to the Horizon Blvd. exit on the right @ first traffic light.
- Turn right on Horizon Blvd. and proceed to stop sign. The Technology Center will be in front of you.
- Make a left turn and the first right turn in front of the complex, which will be on your right on Negron Drive.
- For Auditorium parking, once you have made the right turn onto Negron Drive, proceed straight to the north side of the Center, passing the Center and making a right between the Center and the NJSP Communications Center, entering the Auditorium parking area.

FROM THE PARKWAY:

- Take the Parkway to Exit 98 and proceed west on I-195.
- Take Exit 5A (RT 130 south) to the Horizon Blvd. exit on the right @ first traffic light.
- Turn right on Horizon Blvd. and proceed to stop sign. The Technology Center will be in front of you.
- Make a left turn and the first right turn in front of the complex, which will be on your right on Negron Drive.
- For Auditorium parking, once you have made the right turn onto Negron Drive, proceed straight to the north side of the Center, passing the Center and making a right between the Center and the NJSP Communications Center, entering the Auditorium parking area.

FROM TRENTON:

- Take Rt. 29 South to I-195 East.
- Take Exit 5A (RT 130 south) to the Horizon Blvd. exit on the right @ first traffic light.
- Turn right on Horizon Blvd. and proceed to stop sign. The Technology Center will be in front of you.
- Make a left turn and the first right turn in front of the complex, which will be on your right on Negron Drive.
- For Auditorium parking, once you have made the right turn onto Negron Drive, proceed straight to the north side of the Center, passing the Center and making a right between the Center and the NJSP Communications Center, entering the Auditorium parking area.

FROM ROUTE 1:

- Take Rt. 1 to I-295 South.
- Take I-195 East (Shore Points)
- Take Exit 5A (RT 130 south) to the Horizon Blvd. exit on the right @ traffic light. Turn right on Horizon Blvd. and proceed to stop sign. The Technology Center will be in front of you.
- Make a left turn at the stop sign and then the first right turn in front of the complex (Negron Drive). The main entrance is in the center of the building.
- Take Exit 5A (RT 130 south) to the Horizon Blvd. exit on the right @ first traffic light.
- Turn right on Horizon Blvd. and proceed to stop sign. The Technology Center will be in front of you.
- Make a left turn and the first right turn in front of the complex, which will be on your right on Negron Drive.
- For Auditorium parking, once you have made the right turn onto Negron Drive, proceed straight to the north side of the Center, passing the Center and making a right between the Center and the NJSP Communications Center, entering the Auditorium parking area.
