

Mission Statement

The group's primary purpose is to represent the best interest of compulsive gamblers and their families, recognizing that compulsive gambling is a treatable illness.
- The Council focuses on educating the general public, training professionals throughout the State, referring compulsive gamblers and their families in treatment, and advocating for increased treatment services for compulsive gamblers and their families.
- The Council also advises the New Jersey Department of Human Services, Division of Mental Health and Addiction Services provides the executive and legislative branches of State government with relevant data on all aspects of the compulsive gambling problem; and provides assistance to those private or public agencies in the State who request it.
- The Council neither opposes nor endorses legalized gambling. However, the Council may take positions on various issues surrounding legalized gambling when the members believe that taking a stand is in the best interest of compulsive gamblers and their families.

800Gambler - GAMBLING FACTS

- > The prevalence rate of gambling disorder in the total sample was 6.3%
- ➤ Men (72.8%) were significantly more likely than women (66.9%) to have gambled in the past year and to gamble either online-only or online and at land-based venues.
- ➤ A higher proportion of women (84.3%), compared to men (67.2%), endorsed land-based only gambling.
- ➤ Suicide attempts are 18-25%
- > 70% of Seniors have gambled in the last year
- ➤ Overall, rates of problem gambling were highest among Hispanics, with 16.2% classified in the high-risk problem gambling group, followed by Asian/Others (14.1%).
- > Overall, Whites (76.1%) were significantly more likely than other groups to be classified as non-problem, and Black or African Americans (18.5%), as low-risk problem gamblers.
- Asians have a large problem because their culture has many activities that include gambling and many things are based on luck.

800Gambler - RISK FACTORS FOR GAMBLING IN ADOLESCENTS

- ✓ Having parents with gambling problems
- ✓ Having an earlier age of first gambling activity Fantasy Sports
- ✓ Possessing greater impulsivity
- ✓ Having areas of poor functioning, including medical, psychiatric, and/or substance use disorders and family/social problems
- ✓ Preoccupation with video gaming
