INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2016 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2017 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

¹The term "state" is used to refer to all the states and territories required to comply with Synar as part of the Substance Abuse Prevention and Treatment Block Grant Program requirements (42 U.S.C. 300x-64 and 45 C.F.R. 96.121).

The ASR must be received by SAMHSA no later than December 31, 2016 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2017 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–5 (in Excel) to WebBGAS. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel), as well as a database with the raw inspection data to WebBGAS.
- Synar Inspection Form: States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- Synar Inspection Protocol: States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections. This document should be different than the Appendix C attached to the Annual Synar Report

1. OTCNF continues to conduct the FDA Compliance Check Inspection Program in combination with Synar inspections, (7,696 total retail inspections) which will enhance the number of retailers inspected statewide, which in turn should reduce the overall retail violation rate.

2. Advocates are continuing to educate key stakeholders regarding sustainability messaging to increase activities aimed at enhancing and supporting law enforcement and prevention efforts for the OTCNF.

3. OTCNF and DHS/DMHAS have established discussions to enhance efforts to reduce the retail violation rate for Synar.

4. Twenty-one local municipalities (565 municipalities in New Jersey) have enacted laws to raise the age to sell tobacco products from persons 19 years of age to 21 years of age.

5. Point of Sale - This project aims to characterize tobacco advertising and product availability in retail locations. Monitoring this type of marketing may highlight youth exposure to different types of tobacco products and indicate how exposure may vary among the sample of New Jersey communities. Additionally, ongoing surveillance of point of sale tobacco marketing may inform future legislation restricting this activity.

6. DMHAS provided funding for and printed additional "Look, See, Check ID" materials to be distributed to merchants and DMHAS' 17 community-based regional prevention coalitions.

 \boxtimes Limited resources for law enforcement of youth access laws

The elimination of tax excise appropriation is still in effect for NJ SFY 2017. The Office of Tobacco Control, Nutrition and Fitness (OTCNF) continues to be placed under the Community Health and Wellness Unit. This office manages the funds from the Center for Disease Control and FDA cost reimbursement contract as well as the Tobacco Age of Sale (TASE) program. Starting in NJ SFY 2011, the TASE program only conducts the mandated federal inspections (approximately 400-500 inspections).

Limited resources for activities to support enforcement and compliance with youth tobacco access laws

As a consequence of the decrease in funding, merchant education training, promotional and educational activities were limited. For this reporting year, merchant education training was only provided by inspectors and student associates while conducting inspections.

Limitations in the state youth tobacco access laws

Limited public support for enforcement of youth tobacco access laws

Limitations on completeness/accuracy of list of tobacco outlets

The Department of the Treasury (Treasury) produces the retailer's list with limited staff to verify accuracy. OTCNF and DHS/DMHAS will continue to seek collaboration with Treasury to strategically plan a solution to increase the fidelity of the retailers list.

Limited expertise in survey methodology

Laws/regulations limiting the use of minors in tobacco inspections

Difficulties recruiting youth inspectors

OTCNF requires adult inspectors to hire youth inspectors. Inspectors have noted that difficulties in recruiting youth inspectors are due to the following:

1) Competition from other youth job opportunities. 2) Parental concerns regarding the safety of the youth conducting inspections. 3) Youth participation in sports and other extra-curricular activities.

Issues regarding the balance of inspections conducted by youth inspectors age 15 and under

OTCNF has implemented a system to ensure a proper gender balance for youth inspectors. The gender ratio varies for youth inspectors due to following:

1) Competition from other youth job opportunities. 2) Youth participation in sports and other extra-curricular activities. 3) Inspectors inability to hire youth. 4) Youth unavailable due to vacation.



NJDOH/TASE program recruited and hired part-time adult inspectors under Special Services contracts (Public Health Representatives). These employees perform inspections in all areas of the State and recruit youth inspectors (hired by NJDOH as student associates) from schools, community centers and faith-based organizations.

The TASE adult inspectors are trained by the OTCNF Program Coordinator and/or veteran inspectors. The training includes a protocol and procedures manual developed by NJDOH/TASE. This training manual, The New Jersey Guidelines for Prohibiting the Sale of Tobacco Products to Minors, was developed in June of 1996 and revised in 2003, 2005, 2012 and again in 2016 to ensure standardization in performing inspections. Chapter 3, entitled Compliant Check Inspections Protocol, provides specific training information on how to conduct proper inspections.

The part-time adult TASE inspectors are trained and updated on TASE protocols. Adult TASE inspectors train the youth inspectors, utilizing the training manuals noted above.

The part-time adult TASE inspectors are trained and updated on TASE protocols. Adult TASE inspectors train the youth inspectors, utilizing the training manual and role playing typical inspections. 

The adult inspector transports youth to and from the sites and accompanies them during the attempted buy, particularly when the site is large enough for the adult supervisor to remain inconspicuous. On occasion, based on the discretion of the adult inspectors, the youth inspector may enter the site alone, when a site is so small (e.g. newsstands, kiosk) that suspicion of the clerk would be aroused by the presence of both the adult supervisor and the youth inspector. In all situations, youth inspectors stay within view of the adult supervisor (safety is the primary concern).

The age of hired youth inspectors is currently ages 16-17 old. New Jersey's law (NJSA 2A:170-51.4) prohibits the sale of any tobacco products to any persons under 19 years old. SAMHSA has made all states aware that the hiring of 15 year olds for undercover buys maybe restricted or prohibited by the Fair Labor Standards Act of 1938 (FLSA). TASE has eliminated the use of 15 year old youth inspectors. Youth inspectors are between the ages of 16 and 17 years old.

Adult inspectors are employed by TASE and are compensated monetarily. Youth inspectors employed by TASE are compensated monetarily.

New inspectors are trained by veteran inspectors and/or the TASE coordinator. Youth are trained by veteran youth and the inspector.
