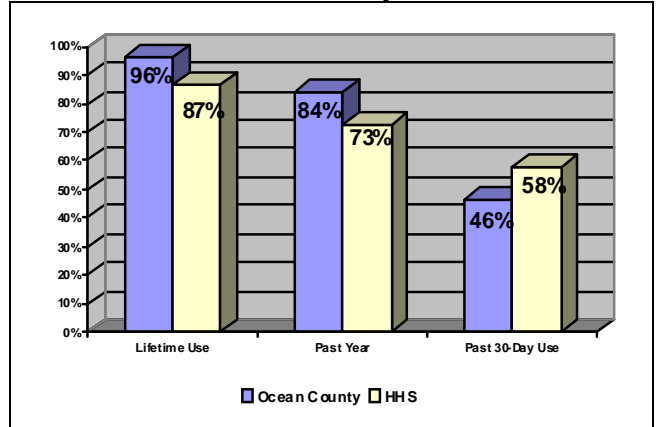


Data were collected on 2,058 clients who went through the Ocean County Intoxicated Driver Resource Center program or were monitored by the Ocean County IDRC in 2009. 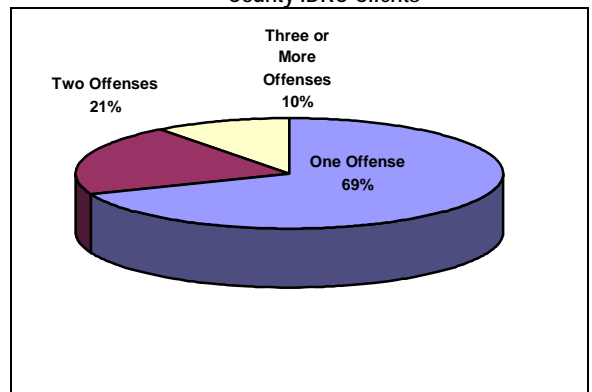

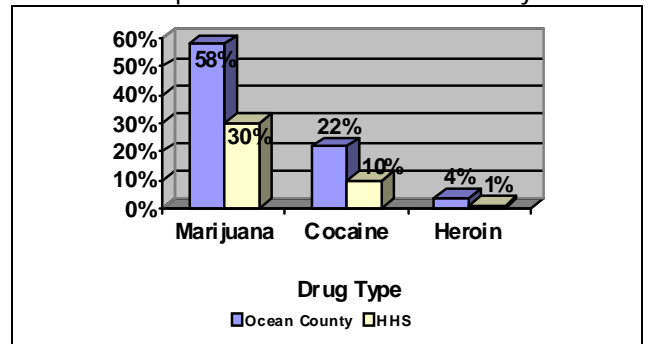
Alcohol Use by Ocean County IDRC Clients Compared with 2003 NJ Household Survey



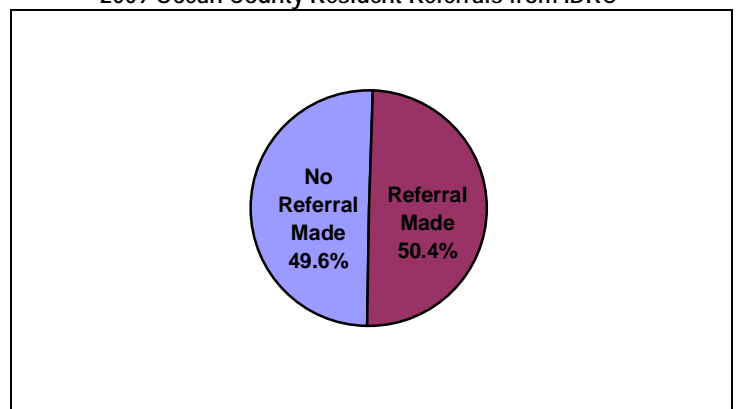
Number of Alcohol-Related Offenses on DMV Records of Ocean County IDRC Clients

2009 Ocean County Resident Referrals from IDRC



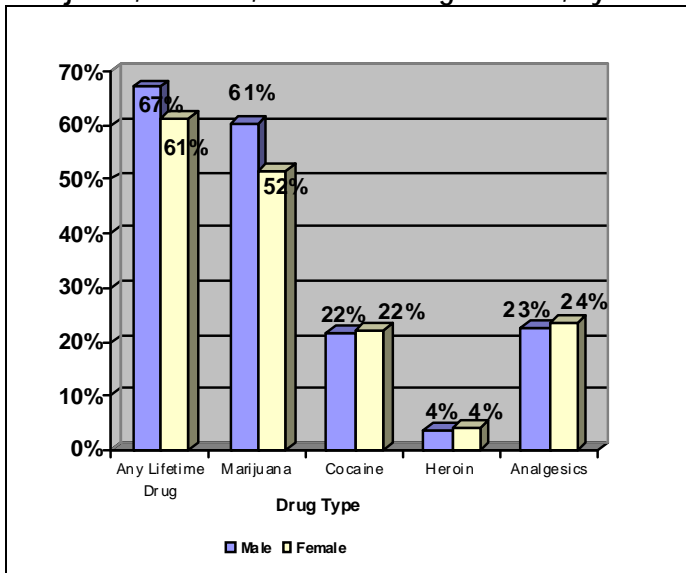
