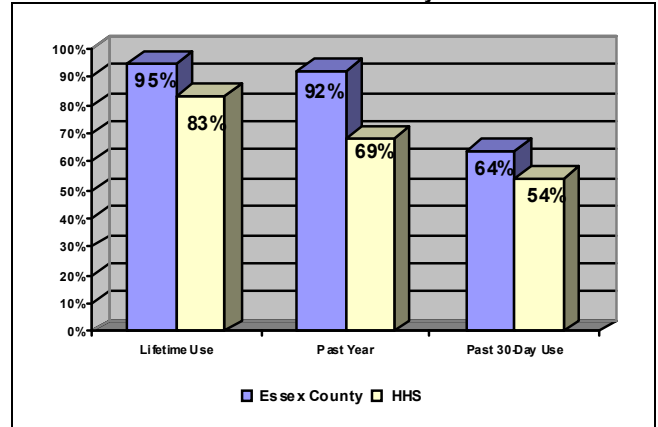

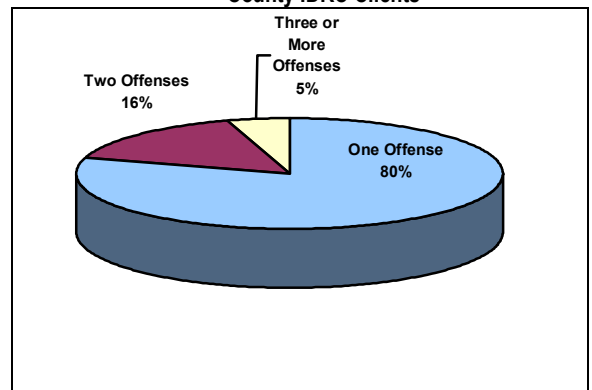

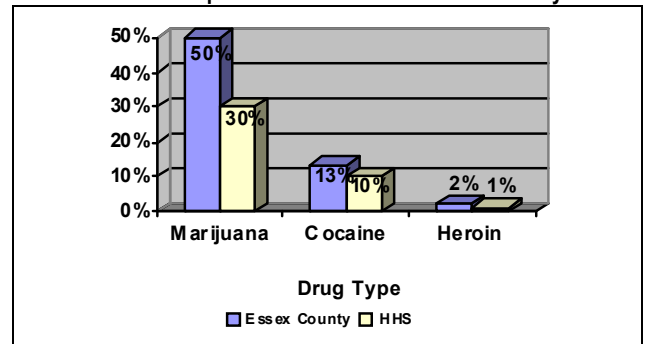
Alcohol Use by Essex County IDRC Clients Compared with 2009 NJ Household Survey



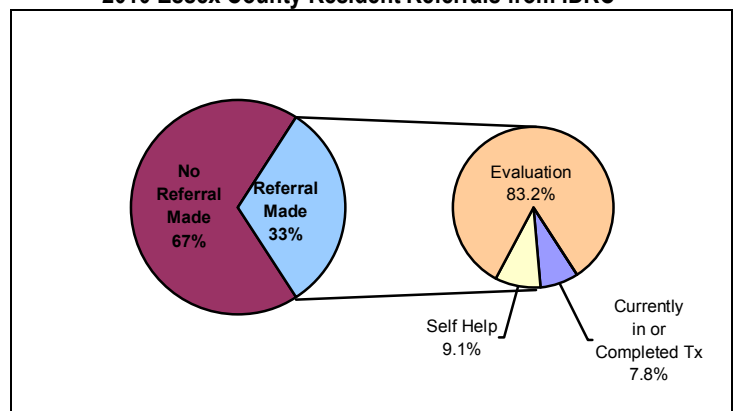
Number of Alcohol-Related Offenses on DMV Records of Essex County IDRC Clients

2010 Essex County Resident Referrals from IDRC



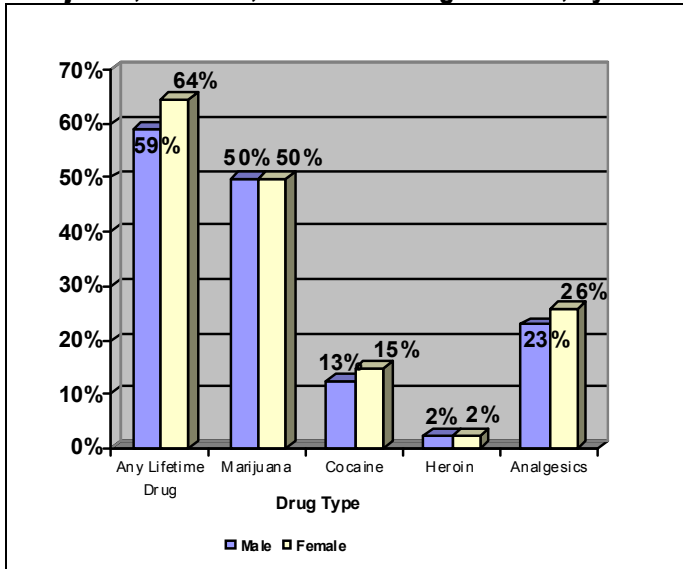
