



**Comparison Between Somerset County and New Jersey Middle School Students  
2012 New Jersey Middle School Risk and Protective Factor Survey**

The 2012 New Jersey Middle School Risk and Protective Factor Survey was commissioned by the Division of Mental Health and Addiction Services (DMHAS) to assess the use of alcohol, tobacco, and other drugs (ATOD), track anti-social behaviors and document risk and protective factors among New Jersey youth. Administration of the survey was carried out by the Bloustein Center for Survey Research (BCSR), Bloustein School of Public Policy at Rutgers, the State University of New Jersey. The survey contained 6,544 respondents statewide, yielding a random sample with a margin of error of +/- 0.8%. The Somerset County portion of the sample contained 353 respondents in 2007, 432 in 2010, and 382 in 2012; therefore, county estimates have a margin of error of approximately +/- 3.1, +/- 2.8%, and +/- 2.9%, respectively. Selected comparisons between Somerset County and New Jersey as well as Somerset County in 2007, 2010, and 2012 are presented below. In 2012, the overall response rate in New Jersey was 40.6%, compared to 38.5% for Somerset County.
