## Comparison Between Union County and New Jersey Middle School Students 2012 New Jersey Middle School Risk and Protective Factor Survey

The 2012 New Jersey Middle School Risk and Protective Factor Survey was commissioned by the Division of Mental Health and Addiction Services (DMHAS) to assess the use of alcohol, tobacco, and other drugs (ATOD), track anti-social behaviors and document risk and protective factors among New Jersey youth. Administration of the survey was carried out by the Bloustein Center for Survey Research (BCSR), Bloustein School of Public Policy at Rutgers, the State University of New Jersey. The survey contained 6,544 respondents statewide, yielding a random sample with a margin of error of +- 0.8%. The Union County portion of the sample contained 328 respondents in 2007, 490 in 2010, and 105 in 2012; therefore, county estimates have a margin of error of approximately +- 3.2%, +- 2.6%, and +- 5.7%, respectively. Selected comparisons between Union County and New Jersey as well as Union County in 2007, 2010, and 2012 are presented below. In 2012, the overall response rate in New Jersey was 40.6%, compared to 11.1% for Union County.
