

The Excluded New Jerseyans Fund (ENJF)

Required Documents



If you were excluded from both the federal stimulus checks and COVID-19 related unemployment assistance, you may qualify for this one-time cash assistance program. Applicants must demonstrate eligibility using one of the following documents under each category, **if you are unable to provide a required document you could still be eligible and should still apply.**

Exclusion from Federal Stimulus and COVID Related Unemployment Assistance

Applicants can demonstrate exclusion in the following ways:

- Bank statements for the months of April & May of 2020, December 2020 & January 2021, and April 2021 & May 2021, **OR**
- Complete 2020 Tax Returns demonstrating that applicant(s) did not receive any federal stimulus.

Receipt of the federal stimulus only applies to the applicant(s); therefore, if another member of your household, for example, your child received this payment, it will not preclude you from applying as long as you did not receive the benefit.

Income that is at or below \$55,000

Applicants can demonstrate their household income by providing One (1) of the items below.

- Joint **OR** individual tax return showing household income at or below \$55,000 **OR**
- Letter from Employer **OR**
- Deposit/Bank records with total balance **OR** Paystubs - Reflect the last 2 months, showing annual income at or below \$55,000 **OR**
- Award Letter from a Social Service Agency (example - Social Security or Veteran Affairs)



Identity, Residency, Age

Documents that Establish Both Identity and Residency
Please select ONE (1) from the list below

- NJ or Municipal ID card
- NJ Driver's License
- NJ Student ID
- Utility, cell phone, or internet bill
- Bank/insurance statement
- 2019 or 2020 Tax Return
- Paystub from employer
- Rent receipt, lease, mortgage
- Letter from social service agency
- Letter from health care provider
- Letter from government agency

Documents that Establish Identity
Please select ONE (1) from the list below

- Student ID card/transcript
- Passport/Birth Certificate /Driver License from any country
- Consulate ID card
- A child's U.S. birth certificate and your name
- Letter from IRS or ITIN
- Marriage/divorce
- U.S. court document

List C
Documents that Establish Residency
Please select ONE (1) from the list below

- Signed and dated letter stating the full name and phone number of the person writing the letter from the following entities:
- Landlord, representative of worship, medical provider, service provider, shelter acknowledging you live in NJ.

COVID Impact

Applicants can demonstrate COVID impact by providing ONE (1) of the items below:

- Tax returns **OR** pay stubs **OR** W2 demonstrating reduced income/wages as a result of employment loss or hours reduction since March 2020, **OR**
- Notice from employer stating a loss of wages, hours, or employment, **OR**
- Proof of rental **OR** utilities arrears since March 2020, **OR**
- COVID illness **OR** death of a household member, **OR**
- Notice from child's school informing of transition to remote learning.
