REQUIREMENTS:	<p>EXPERIENCE:</p> <p>Two (2) years of experience in the operation and maintenance of varied types of refrigeration and air conditioning equipment.</p>				
LICENSE:	<p>Appointees will be required to possess a valid Air Conditioning and Refrigeration Technician Certification of the appropriate level, commensurate with the type of equipment serviced, issued under authority of the Federal Environmental Protection Agency.</p> <p>Appointees will be required to possess a Refrigeration Plant Operator's License of the appropriate grade and type WHEN the position required operation of refrigeration systems using toxic or flammable refrigerants of the size and capacity as established under provisions of NJAC 12:90-3.8.</p> <p>Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform essential duties of the position.</p>

RESIDENCY:	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
