REQUIREMENTS					
EDUCATION	Possession of a valid registration as a Licensed Practical Nurse in New Jersey. Persons who possess the registration by waiver must have satisfactorily completed an approved refresher program.				
EXPERIENCE					
NOTE	This position complies with the Centers for Medicare and Medicaid Services (CMS) Rule and Executive Order 283, requiring certain employees to be fully vaccinated. To comply with this requirement, applicants must provide proof of vaccination status during the employment process.

RESIDENCY	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.
