Commissioner Adelman and Senator Vitale Unveil

Comprehensive Package to Enhance Safety and Accountability

in Developmental Disability Services

Commissioner Sarah Adelman and Senator Joseph Vitale announced a legislative package aimed at enhancing the health and safety of individuals with developmental disabilities.

"These transformative bills represent more than legislative progress; they mark a significant stride in our ongoing commitment to ensure that individuals with intellectual and developmental disabilities are not only safeguarded but also empowered to thrive within our communities," **Commissioner Adelman said.**

"By enhancing protections and boosting accountability for providers, we underscore our dedication to enabling every person to achieve their full potential and live with the dignity and respect they deserve. I extend my gratitude to Senator Vitale for his efforts and look forward to working collaboratively as these vital initiatives advance. Together, we share a unified goal: a promise to protect and support every individual."

"I'm excited to spearhead this comprehensive package of reforms to improve the services provided to our residents with intellectual and developmental disabilities, both by service providers and by the Department," **Senator Vitale said.** "Our shared commitment is that every individual with intellectual and developmental disabilities lives in a safe and supportive environment. By implementing these measures, we are safeguarding the rights of individuals and ensuring they can thrive and fully participate in communities across New Jersey."

The package includes bills that:

- Enhance state enforcement authority and establish financial penalties;
- Establish new provider governance and service standards;

- Require directors of medical services to enhance investigations of abuse and neglect involving individuals with complex medical needs;
- Create a Disability Mortality and Abuse Prevention Advisory Committee;
- Establish a system for receiver appointment:
- Streamline investigations; and
- Require workforce survey participation.

"Human Services is continuously committed to fostering a safe and dignified environment for individuals with developmental disabilities," **Commissioner Adelman said.** "This legislative package not only enhances accountability among service providers but also amplifies the voices of those with lived experience in shaping the services they receive."

Governor Murphy Announces Over \$25 Million in Additional Opioid Response Investments

Governor Phil Murphy announced the allocation of more than \$25 million from New Jersey's Opioid Recovery and Remediation Fund to support additional efforts tackling the opioid crisis, including expanding legal services for those in recovery, enhancing youth substance use treatment and prevention, and boosting emergency response efforts. The newly allocated funding builds upon more than \$95 million in opioid settlement spending announced earlier this year.

"While our collective battle against the overdose epidemic is far from over, we have made tremendous progress in expanding evidence-based care and community-informed support to more New Jerseyans. With today's announcement, we are reaffirming our commitment to support both individuals and communities that continue to face the tragic impacts of the overdose crisis," said Governor Murphy. "By leveraging the State's Opioid Recovery and Remediation Fund, we are expanding programs with a proven success record to more New Jersey communities over the next three years and bolstering our preparedness to respond to new opioid-related public health challenges. These crucial investments will save lives and help our neighbors struggling with addiction, wherever they are on their journey to recovery."

Based on the recommendation of the State's Opioid Recovery and Remediation Advisory Council, the newly allocated funding will provide:

\$20.25 million over three years to expand efforts to provide free
civil legal services to individuals with mental health or substance use
disorders. This funding will reduce the burden of outstanding legal issues
on an individual's pursuit of wellness, recovery, and community

- integration. The Department of Human Services would implement two models: a medical-legal partnership model that helps with treatment and a regional legal services model for broader assistance.
- \$5.04 million over three years to expand statewide the Department of Children and Families' South Jersey Youth Substance Use Initiative, which helps youth ages 13 through 17 years access substance use treatment and care services. The expansion will make outpatient, intensive outpatient, and short-term residential treatment programs more accessible statewide, and offer early intervention services for youth who are engaging in substance use and may be at risk for dependence. Services, including family treatment, will be designed to provide support for youth as well as their parents and caregivers.
- \$500,000 to boost the State's ability to swiftly and effectively respond to emergencies. This replenishes \$500,000 held for opioid emergency response to bolster the State's ability to swiftly and effectively respond to emergencies in the opioid crisis as they emerge. Emergency funds were used over the past year to deploy wound care supplies, hygiene kits, and xylazine testing supplies to address the emerging threat in the drug supply of fentanyl adulterated or associated with xylazine.

"This funding reflects our continued and unwavering commitment to support individuals and families impacted by the harms of the opioid crisis," said Commissioner Sarah Adelman, who chairs the Opioid Recovery and Remediation Advisory Council. "By investing \$25 million in settlement funds to expand legal services, enhance youth treatment and prevention programs, and strengthen emergency response capabilities, we are not only responding to immediate challenges but paving the way for long-term recovery and resilience.

I thank my fellow Advisory Council members and all of the community members and partners who provided input to guide these recommendations."

NJ Human Services Awards Contracts to Opioid Treatment Providers to Expand Access to Mobile Medication Services

Human Services announced that \$3.2 million in contracts have been awarded to provide mobile medication services to individuals with substance use disorder (SUD) who may encounter obstacles to receiving services at traditional 'brick-and-mortar' treatment agencies.

The expansion is funded through the allocation of New Jersey's opioid settlement funds announced by Governor Murphy in February 2024.

"The goal is to eliminate barriers to treatment and save lives by meeting people right where they are. These funds, which are opioid settlement dollars in action, will target underserved areas and expand access to treatment options and other services and supports to those who need it most," said Commissioner Sarah Adelman.

Mobile medication services are expected to begin in 2025. Three awards were issued, one in each of the following counties; Monmouth, Middlesex, and Burlington. These new mobile vans will run in addition to the eight that currently operate in New Jersey. This expansion will enable mobile medication services to be available in the above-mentioned counties, as well as Ocean. "Hard-to-reach populations are not likely to access traditional health care and social services on their own due to a number of barriers including mental illness, unstable housing, or lack of transportation. Stigma and lack of trust also keep people from seeking out services. Mobile vans can go where help is needed and connect people to treatment and services that will hopefully lead to long-term recovery," said Deputy Commissioner of Health Services Valerie Mielke.

"We know that people who are facing instability in their lives will seek treatment more readily when services are brought to them. These mobile units can help us reach individuals most in need of these services in multiple neighborhoods.

They can also help build trust by becoming a recognizable and helpful presence in the community," said Division of Mental Health and Addiction Services (DMHAS) Assistant Commissioner Renee Burawski.

Providers must develop a plan to publicize the route and schedule to the communities being served. They must also partner with other DMHAS-funded initiatives designed to increase access to medications for substance use disorder to the targeted population.

Governor Murphy Highlights More Than \$1 Billion Investment in Child Care Sector Since Start of Administration

Governor Phil Murphy highlighted how his Administration has invested more than \$1 billion in expanding access to high-quality, affordable child care. The Governor also announced an additional \$17 million in funding for the New Jersey
Economic Development Authority (NJEDA) Child Care Facilities Improvement

Program.

"Affordable, exceptional child care is a vital part of a stronger and fairer New

Jersey economy, and the increased funding announced today will strengthen our state's economic security and provide equitable opportunities to working parents," **Governor Murphy said.** "Increased access to high-quality child care allows more parents to return to the workforce, bolstering New Jersey's economic growth and competitiveness. Thank you to the Biden-Harris Administration, who have provided record-high federal funding to expand access to child care, health care, and other critical resources for families in the Garden State."

"Reliable and high-quality child care services are critical to the growth and success of New Jersey's economy; however, too often financially stretched child care providers forgo making necessary investments in facility upgrades," NJEDA Chief Executive Officer Tim Sullivan said. "The Child Care Facilities Improvement Program is an essential part of Governor Murphy's goal to support working families and to build a more inclusive economy."

"This investment continues the Murphy Administration's commitment to support quality child care providers that are vital to New Jersey's working families and the state economy. Today's announcement complements \$3.6 million in Fiscal Year 2025 child care provider wage increases and Human Services' Child Care Assistance Program subsidies for tens of thousands of New Jersey families,"

Commissioner Sarah Adelman said. "With a focus on improving learning environments, these NJEDA grants will empower child care providers to make necessary enhancements to their facilities, expand access to high-quality child care services, and strengthen our early childhood education system."

NJ Human Services Awards Contract for Crisis Prevention & Intervention Team Serving Individuals with Intellectual and Developmental Disabilities and Mental Health Needs

Commissioner Sarah Adelman announced Human Services has awarded a contract to develop evidence-based, community crisis prevention and intervention services for individuals with intellectual and developmental disabilities and mental health needs.

Human Services' <u>Division of Developmental Disabilities</u> (DDD) awarded a \$3.2 million in contract to create a new START Model program. The contract was awarded to the Young Adult Institute, or YAI. The program is projected to begin in spring 2025. The program will be active in Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester, Mercer, Middlesex, Monmouth, Ocean, and Salem counties.

START – which stands for Systemic, Therapeutic, Assessment, Resources, and Treatment – provides community-based crisis prevention and

intervention services for individuals with intellectual and developmental disabilities and mental health needs. This model will expand community capacity to provide an integrated response to adults at risk of or experiencing a behavioral health crisis, their families, and those who support them, and to foster cross-systems relationships that support the health and wellbeing of each person served. The program focuses on reducing emergency room visits, hospitals admissions, caregiver burnout, and calls to law enforcement as well as building community capacity to successfully support people with intellectual and developmental disabilities and mental health needs.

"START is well-regarded for its individualized, solution-oriented methods that utilize positive psychology and other proven practices to address mental health issues, particularly those that are frequently misdiagnosed, under-diagnosed, or overlooked in individuals with intellectual and developmental disabilities," **Commissioner Adelman said.** "This contract award marks another advancement in our efforts to enhance and broaden crisis response services, ensuring top-quality care for those with intellectual and developmental disabilities. Their safety and quality of life remain our top priorities."

"This groundbreaking approach will move us closer to our objective of delivering the most thorough services for all adults with intellectual and developmental disabilities, including those with complex behavioral and mental health needs," **Deputy Commissioner for Aging and Disability Services Kaylee McGuire said.** "By implementing the START model, we are broadening the range of support options to enhance our crisis response and prevention strategies with proven, effective methods."

"We are eager to roll out this program to enhance crisis response for individuals with intellectual and developmental disabilities," **DDD Assistant**


