

Help for Immigrant Victims and Survivors of Violence

If you or someone you know has experienced domestic violence, sexual violence, human trafficking, or other crimes, help is available.



Where to Get Help

Support is available for victims and survivors of domestic violence, sexual violence, human trafficking, and other harm. Services may include 24/7 hotlines, shelter, legal help (including immigration), safety planning, and counseling. Language support is available and some provide culturally specific services.

Crisis Response Teams are available 24/7 to support victim and survivors.

- **Domestic Violence Response Teams (DVRT)** are activated by police with your consent. Trained volunteers will meet you at the police station for emotional support, restraining order information, and referrals to services.
- **Sexual Assault Response Teams (SART)** are activated with your consent by calling 911 or going to the police, a hospital, or sexual violence provider. The team includes a confidential advocate, a forensic nurse, and a police officer. You can decide to work with one, two, or all three team members.

New Jersey's Immigrant Trust Directive

Some immigrant victims and survivors may be afraid to report a crime because they worry it could affect their immigration status. New Jersey's Immigrant Trust Directive helps ensure victims or witnesses can safely report crimes to law enforcement, regardless of immigration status. Immigration Relief Options

If you are an immigrant victim or survivor of a violent crime or abuse, you may be able to apply for immigration relief for yourself and your children.

(Please note that any noncitizen can be subject to routine immigration detention and deportation.)

Immigrant victims or survivors of crimes like domestic violence, sexual violence, human trafficking, or kidnapping may be able to apply for a U Visa. [Learn more from US Citizenship and Immigration Services](#)

[T Visa](#)

Immigrant victims or survivors of human trafficking, including those trafficked for sex or forced labor, may be able to apply for a T Visa. [Learn more from US Citizenship and Immigration Services](#)

Obtaining a U Visa or T Visa Certification:

To request a U or T Visa certification, visit the website or call the law enforcement agency involved in the case for instructions. The NJ Department of Labor may provide certifications if the harm is discovered during a workplace investigation. [Special Immigrant Juvenile Status \(SIJS\)](#)

Immigrant children and youth under age 21 may qualify for legal protection through SIJS if they have experienced abuse, abandonment, neglect, or the loss a parent.
