Introduction

The *DHS Directory of Contracted Services* is published to inform the general public, as well as potential provider agencies, of the services contracted under DHS throughout the state of New Jersey. The directory is organized by contracting units and service categories, and includes information detailing the spectrum of services provided by DHS.

The Request for Proposals (RFPs) for **new** funding are published on the DHS Website at <http://www.state.nj.us/humanservices/grantan.html>, along with the service to be developed and the corresponding contact information. The funding for contract services may come from a variety of sources including New Jersey state appropriations, federal funds and private grants.

The DHS has eight “Departmental Component Contracting Unit (s)” that purchase third party services including the divisions of Developmental Disabilities; Family Development; Medical Assistance and Health Services; Addiction Services; Disability Services; along with the Commission for the Blind and Visually Impaired and the Office for the Prevention of Mental Retardation and Developmental Disabilities.

DHS makes every effort to work to serve New Jersey’s most vulnerable citizens, including people with developmental disabilities, adults with serious and persistent mental illnesses, individuals who are blind and visually impaired, and people with alcohol and drug addiction problems. The services provided through DHS are made available in concert with the state’s non-profit and for-profit human services organizations, and the state’s public/hospital-based community providers.

Any concerns, questions or information updates regarding the *DHS Directory of Contracted Services* should be made by contacting a specific Departmental Component Contracting Unit, as well as the DHS Contract Policy and Management Office at 609-292-9469. The directory is organized and distributed annually through Contract and Policy Management Office to assist consumers with understanding the department’s contracted services, along with related budget, legislation, process and procedure.
