Program Name: State Health Insurance Assistance Program (SHIP) Burlington County 2022.

Purpose: The purpose of this grant is to fund a local agency which will serve as the point of contact for Medicare beneficiaries within Burlington County who have questions about Medicare. The agency funded under this grant will be required to designate a qualified agency staff member or volunteer as the Burlington County SHIP Coordinator who will work at least 15 hours per week and who will be responsible for managing the existing ten (10) volunteer SHIP counselors within the county, receiving and assigning referrals, promoting the SHIP program within the county, completing quarterly reports to DoAS, and administering the SHIP program according to the Scope of Services.

Available Funding Amount: Total funding available is \$40,000 for a seven (7) month period, September 1, 2022 to March 31, 2023.

Requirements to Apply: To be eligible for consideration, the applicant must be a qualified non-profit or governmental entity. Agencies must be experienced in delivering information and assistance to residents age 65 and older and/or to adults with disabilities ages 18-64 in Burlington County.

Proposal Procedure: Effective July 8, 2022, the request for proposal (RFP) is available at http://www.state.nj.us/humanservices/providers/grants/rfprfi/. Submitted proposals must comport with the RFP requirements and instructions.
