GRADUATE MEDICAL EDUCATION - TRAUMA**

TAKE NOTICE: The New Jersey Department of Health (DOH), in coordination with the New Jersey Department of Human Services (DHS), Division of Medical Assistance and Health Services (DMAHS) intends to seek any required approval from the United States Department of Health and Human Services (HHS), Centers for Medicare and Medicaid Services (CMS), for an amendment to the New Jersey Medicaid (Title XIX) State Plan, in order to implement the following, subject to the passage of State Fiscal Year 2026 (SFY 26) budget provisions for the period July 1, 2025 through June 30, 2026.

For SFY 26, the State identified a need for dedicated funding to better support the State's Level I and Level II Trauma Centers, which are a necessary and vital part of the State's healthcare landscape. By dedicating funding to Trauma Centers, the State created a subsidy through the Appropriations Act called GME-T to support training and education of future physicians at the State's Trauma Centers.

Hospital Reimbursement for GME-T

Notwithstanding the provisions of any law or regulation to the contrary, and except as otherwise provided and subject to such modifications as may be required by CMS in order to achieve any required federal approval and full Federal Financial Participation, \$84,500,000 from amounts appropriated GME shall be designated as Trauma Center Graduate Medical Education Subsidy (GME-T), and shall be available to hospitals that have a residency program and are designated as Level 1 or Level 2 Trauma Centers by the Department of Health (DOH). The GME-T Subsidy shall be calculated using the same methodology as the GME Subsidy is calculated, except the total aggregate amount of the GME-T Subsidy payments to eligible hospitals shall not exceed \$84,500,000.

This Notice is intended to satisfy the requirements of Federal statutes and regulations, specifically 42 CFR 447.205, and 42 U.S.C. 1396a(a)(13).
