YOUR WORKPLACE RIGHTS IN NJ

The NJ Department of Labor is committed to assisting and protecting farm workers, regardless of immigration status. For more information regarding your rights and to file a complaint visit nj.gov/labor/farmworkers. You can also email farms@dol.nj.gov or call **609-292-2305** to discuss your case.

- Pay for all hours worked with no illegal deductions.
- Up to 40 hours of Earned Sick Leave.
- Protections from being illegally fired or punished.
- Protections if employed by a crew leader.

WIOA Training Grant - Up to \$4,000 vocational training grant for those who qualify

Tuition Assistance - For the unemployed seeking to take classes at a NJ state college

Learning Link - Classes for basic skills upgrade and to obtain your high school equivalency (GED)

DO YOU LIVE IN EMPLOYER-PROVIDED HOUSING?



Per federal law, employer or crew leader housing must be safe and healthy:

- Protection from wind, rain, ground dampness and fire hazards.

- Sleeping areas must be free of vermin and contagious/infectious matter.
- All rooms must be well ventilated and clean.
